FACILITIES PLANNING AND CONSTRUCTION

Housing I HVAC Update

This project entails the demolition and reinstallation of hot air furnaces and hot water heaters in 256 garden-style apartments located in the Housing I complex. This project is expected to commence in late May 2005 and be substantially completed by August 15, 2005. Once completed, this venture will improve the performance and reliability of the utilities in Housing I and upgrade the complex infrastructure to the same level as the other three campus housing units.

Academic Exterior Repairs and Replacement Update

Warmer weather conditions have allowed the painting of the rehabilitated exterior panels of the main academic campus buildings facade, which was halted during the winter months, to resume. This work, in conjunction with various punch list items, will complete the main portion of the original Project Scope. Change orders to repair and replace the panels in M-Wing (Performing Arts Center) and N-Wing are currently being negotiated by the New Jersey Department of Property Management and Construction (NJDPMC) and are expected to be finalized by the end of May. Depending on weather conditions, this additional work will continue throughout the end of 2005 and early 2006.

Academic HVAC Replacement Update

The project, which entails the extension of the geothermal cooling system to additional academic campus buildings and the installation of a cooling tower next to Parking Lot I, is ahead of schedule. Approximately 65% of the contracted work has been completed. Excavation adjacent to the main parking lots for the installation of the cold water distribution piping, which had been deferred until the end of the spring semester, has resumed.

Miscellaneous Renovations Update

Currently, Plant Management is heavily involved in the renovation of Upper K-Wing and the "Verizon" building. The "Verizon" building is scheduled for occupancy in early July, which will allow portions of upper and lower J-Wing to be available for renovations of office spaces for faculty and administration. The ongoing renovations of upper K-Wing will be temporarily stopped to allow Plant Management staff to make faculty offices available by the beginning of the fall semester. Completion of upper K-Wing renovations is scheduled for fall 2005.

Lake Fred Spillway Repairs Update

Lowering the water level of Lake Fred and a fish salvage operation in order to rehabilitate the spillway is currently on schedule. The initial fish salvage

operation was conducted on May 17th and 18th. The process requires a second salvage operation scheduled for July 15th and 16th. The construction phase of the project is scheduled to begin at the end of May and continue through the summer months.

F-Wing Extension and Renovation

Demolition for the F-Wing Extension and Renovation project is 90% complete. The contractor has completed building temporary protection walls on the first and second floors. The protection walls in front of the Library will remain in place throughout the duration of construction. Through the efforts of the Provost and the Division of Academic Affairs, Stockton students will provide artwork and murals to help enhance the experience of walking through a more narrowed gallery space.

Steel delivery is scheduled for the end of May. Steel erection will begin the building enclosure phase that is scheduled to be completed during September 2005. The building enclosure will allow the College to restart using the NAMS laboratories while the contractor is finishing the remaining construction.

PLANT MANAGEMENT

The Department of Plant Management continues to support and coordinate the construction projects initiated by Facilities Planning and Construction. This includes providing support for the ongoing academic exterior and fire suppression projects, the campus-wide HVAC project and the F-Wing overbuild.

F-Wing overbuild – Plant Management, in coordination with NAMS staff, has moved the Laboratory offices to temporary locations in C-Wing and the A&S building. The Electrical Section upgraded power distribution and installed temporary power, and the Plumbing Section installed safety equipment (emergency eyewash/shower) in these locations to support the relocation of ongoing research programs and projects. Plant staff relocated Mail Room operations to allow additional foundation reinforcement work to continue. Plant Management and Event Services also relocated several programs including commencement reception and the ETTC conference. In addition, Plant staff repaired loosening quarry tile, which was a result of the ongoing demolition.

Verizon Building – Plant Management is performing the renovation of this facility; interior paint, ceiling replacement, carpet installation and plumbing work is complete. Electrical and modular partition installation work continues.

Work continues on upper K-Wing, and upper and lower J-Wing renovations.

Electronic classrooms – In cooperation with Computer Services, the conversion of B112, B114, F209 and N115 to electronic classrooms is substantially complete.

Ongoing Plant Management-initiated maintenance projects including: the L-Wing swimming pool refinishing, I-wing gym floor refinishing, parking lot striping, main campus rooftop HVAC units, curbing, gas piping refinishing/painting, PAC seating reconditioning, replacement of check valves at Sewage Lift Station #1, replacement of all Housing I potable water shutoff valves (16 per court), installation of aluminum diamond plate in elevators for wall protection, Housing II exterior courtyard lighting upgrade, and Lakeside Center exterior lighting upgrade.

Plant Management continues to work closely with the offices of Event Services and Housing/Residential Life on an aggressive summer 2005 maintenance, refurbishing and renewal schedule, incorporating Housing summer sessions and summer conferencing schedules. These include the following projects approved by Board of Trustees: Housing III exterior restoration, Housing II draperies replacement, Housing I living room furniture replacement, year two of a two-year mattress replacement project that will complete all Housing areas, year two of five-year bed replacement project that will complete Housing I, and installation of ceramic tile flooring in 18 ground floor apartments.

Plant Management continues the upgrading of ceilings and carpet where most needed throughout the campus.

The men's soccer team held its Seventh Annual Stockton Men's Soccer Scramble Golf Tournament at Centerton Country Club on April 22. The event, the most successful one to date, included 149 participants and raised \$7,191.

JON HECK, Coordinator of Athletic Training, was named the Chair of the Video Committee for the National Athletic Trainers' Association/American Football Coaches Association Sparring Task Force. The committee is charged with producing a 20-minute video/DVD regarding the prevention of catastrophic head and neck injuries in football. The project will be privately funded and is expected to have a production budget of \$20,000-\$25,000. The video has an anticipated completion date of August 2006 and will be distributed to every NCAA school that has football. Other committee members include Dr. Joe Torg, MD, Temple University; Dr. Robert Canut, MD, Chief of Nuerosurgery at Emerson Hospital in Massachusetts; Julian Bales, MD, Chief of Neurosurgery at West Virginia University; and Dr. Fred Mueller, Ph.D and Director of the National Center for Catastrophic Sports Injury Research, University of North Carolina.

G. LARRY JAMES, Dean of Athletics and Recreational Programs and Services, represented the NCAA at the meeting of the joint NCAA/USOC (United States Olympic Committee) Task Force in Colorado Springs, Colorado. The purpose of the task force is to explore affecting change regarding the decline in sponsorship of Olympic sports.

OFFICE OF CAREER SERVICES

The Office of Career Services hosted its fifth annual Summer Job Fair, which was held on April 13 in the E-Wing Gallery. Forty-five area employers participated. **CORA PERONE**, Assistant Director of Career Services, and **EDITH MAUL**, Workforce New Jersey Campus Representative, coordinated this event.

Career Services hosted its Sixth Annual Business Etiquette Dinner on March 31 in the N-Wing Cafeteria. This interactive workshop was sponsored by RSC Alumni Association, Chartwells Dining and the RSC Accounting and Finance Society. One-hundred students, alumni and guests participated in this event coordinated by **Cora Perone** and **Edith Maul**.

OFFICE OF THE COLLEGE CENTER

The Spring 2005 Senior Toast program was held in the Sports Center on April 21. Door prizes were provided by the Office of the College Center, Office of Alumni Relations, and several of the College's vendors. This 12-hour workshop, designed to be presented over a weekend, received high praise from the students. Stockton became the only college in the country to complete this program in one day.

Director of Student Development, were inducted into the National Leadership Honor Society, Omicron Delta, Kappa, on April 24. **O'Donnell** is also a member of Order of Omega, the National Honor Society for Greek Organizations, for which he will introduce a new chapter next spring at Stockton.

Thomas O'Donnell presented the workshop "Developing Leadership Models in Student Affairs" at the National Association of Campus Activities Conference in Minneapolis, MN, in February. He attended the conference with seven Stockton students from the Board of Activities.

OFFICE OF THE VICE PRESIDENT FOR STUDENT AFFAIRS

DR. DEE MCNEELY-GREENE participated in the two-day professional development seminar "The Essentials of Communicating with Tact and Finesse" in Atlantic City, April 11-12.

McNeely-Greene co-presented a session at the Seventh Annual PA-National Association of Multicultural Education conference in Selinsgrove, PA, April 15-16. The session was titled "Transcending Taboos: Talking About Sexuality, Spirituality and Multiculturalism in the Classroom."

SOUTHERN REGIONAL INSTITUTE

DR. HARVEY KESSELMAN, CEO of the Southern Regional Institute and ETTC served as a peer reviewer of grant applications for the U.S. Department of Justice, Office of Violence Against Women during the week of May 1st-6th. The applications were from colleges and universities throughout the United States and Puerto Rico. The grants are to be used to provide victims of sexual assault and other forms of violence with comprehensive support services, and to insure that institutions of higher education hold perpetrators accountability for their actions. Dr. Kesselman has been asked to serve on this panel for several years.

Dr. Kesselman presented a workshop on May 19th entitled *Navigating Through College Admissions, Financial Aid, and NCAA Athletics* at the Oakcrest High School auditorium. The program was geared towards high school athletes and their parents, and students and families from throughout the region attended this highly successful event. Several high schools joined together to promote the program.

Dr. Kesselman also made a presentation to the Cape/Atlantic Principals and Supervisors Association on May 18th in Atlantic City. The presentation focused on the professional development needs of southern New Jersey principals and supervisors. The SRI/ETTC will partner with Dale Carnegie Training to offer workshops and seminars to this constituency.

Dr. Kesselman joined former NJDOE Commissioner Vito Gagliardi in a meeting to discuss and promote the delivery of an online workshop through the SRI/ETTC that would provide educators with pertinent information regarding child neglect and/or abuse. Former Commissioner Gagliardi has been working with the Monmouth-Ocean Educational Services Commission in the development of this required orientation program for all preK-12 personnel in New Jersey. Dr. Dan Loggi, Atlantic County Superintendent of Schools also attended the meeting.

Dr. Kesselman and Dr. Charles Ivory, Executive Director of the Educational Information and Resource Center (EIRC), met to discuss the possibility of the SRI/ETTC housing some of EIRC's Learning Resource Center and Special Education materials in the college's Mays Landing facility. The EIRC has an extensive collection of these materials, and is interested in partnering with the SRI/ETTC to insure that southern New Jersey teachers have greater access to this resource

PATRICIA WEEKS, Director of the Southern Regional ETTC attended a conference on April 15, 2005 entitled "Gifted Education: Making a Difference in Childrens' Lives" at the New Jersey Department of Education's Southern Regional Office in Sewell. The keynote speaker, University of Connecticut's Dr. Joseph Renzulli, provided information and insights regarding his nationally-recognized "School-Wide Enrichment Model" for gifted youth.

On April 6th, the SRI/ETTC offered its first online professional development experience. Fifteen educators signed into the web-based workshop at 7 PM for a one-hour interactive lesson on ethics and copyright policy. The highly informative program received high scores from attendees who participated in the session from their home computers.

The SRI/ETTC hosted representatives from the New Jersey Department of Education at the college's Mays Landing facility on April 15, 2005 who invited school district personnel from across the region to learn more about the reporting requirements of the state's web-based School Violence and Vandalism Report. Nearly 60 school administrators attended the session.

On May 3rd, the SRI/ETTC hosted the 2005 Spring Showcase for the college's Master of Arts in Instructional Technology (MAIT) Program at the Mays Landing facility. Fifteen MAIT students were able to present and demonstrate their final graduate projects using the state-of-the-art educational technologies at the facility.

The SRI/ETTC held its 5th annual *From My Classroom to Yours*, a teacher-to-teacher conference that offered teachers, technology coordinators, and educational administrators the opportunity to share "best practices" for teaching and learning on Wednesday, May 11, 2005 at the Richard Stockton College of New Jersey in Pomona. Nearly 400 educators visited the campus to attend 52 individual sessions throughout the day. **Stockton President Dr. Herman J. Saatkamp, Jr.**, welcomed the educators to the college.

On June 7, 2005 the SRI/ETTC welcomed school superintendents, school board presidents and school business administrators to a program entitled "School Board Policy, Administrative Procedures and Critical Issues" which was held at the Lakeside Center at Stockton. Participants learned about the retention and disposal of board materials, disclosure and management of school reports and public records law among other topics.

The SRI/ETTC hosted "Intel Teach to the Future Leadership Forum" for public school administrators on June 9 at the Carnegie Library Center in Atlantic City. The forum guided participants in the development of personalized action plans to improve effective use of technology in their schools. During the interactive forum, administrators were able to examine the critical role educational leaders play in the effective integration of technology into teaching and learning, and were also able to analyze the ISTE National Educational Technology Standards for School Administrators.

The SRI/ETTC has offered 639 workshop and programs since July 1, 2004.

- WHEREAS,** since that time, the College has expanded its graduate offerings so that it now offers eight programs that serve over 400 students; and
- WHEREAS,** an important component to graduate education is the offering of graduate assistantships, which generally provide tuition waivers and/or stipends to help recruit, retain and expand knowledge and skills of graduate students; and
- WHEREAS,** the offering of graduate tuition waivers is consistent with N.J.S.A. 18A:64-13, which permits the Board of Trustees to waive tuition to accomplish mission-related or policy goals; and
- WHEREAS,** on April 12, 2000, the Board of Trustees approved tuition waivers for students participating in the Graduate Assistantship program as long as the cumulative number of annual graduate tuition waivers does not exceed an average of three waivers per graduate program; and
- WHEREAS,** College policy, financial aid, and veteran's benefits programs define a full-time graduate student as one who carries at least 9 credits; now therefore be it
- RESOLVED,** that the Board of Trustees approves a formula for funding the College's graduate assistantship program that is equal to 9 credits times three per program times the number of programs per semester, for each of two semesters per year; and be it further
- RESOLVED,** that the funding will be indexed to each semester's tuition; and be it further
- RESOLVED,** that student tuition waiver amounts will be equivalent to their residency status (in-state or out-of-state).

Beginning in September 2003, The Richard Stockton College of New Jersey partnered with two “high needs” yet diverse school districts in Atlantic County – Buena Regional and Atlantic City - to meet the overarching goal of the Improving Teacher Quality Partnership, improving student academic achievement. To work towards this goal, the college provided customized professional development (CPD) activities in the content area of mathematics to participating K-8 teachers in each partner district.

In Year Two, building principals from the Edgerton Memorial Elementary School and the Cleary Middle School in the Buena Regional School District as well as the principal from the New York Avenue School, a K-8 building in Atlantic City, selected two teachers from each grade level in their buildings to participate in the Year Two Cohort of the CPD Program. Primary activities associated with the project during the year included workshops in mathematics content delivered by members of Stockton’s faculty, consultation with a mentor/coach once a week on-site in each building, workshops to guide teachers in the integration of technology, and the development of an online community for participants to share ideas and resources. By June 2005, each of the participants will have attended 15 hours of workshops built around the five strands of the New Jersey Mathematics Content Standards.

Each of the buildings has been equipped with a technology station that includes a laptop computer, scanner, digital camera and an LCD projector. The mentors use the equipment to demonstrate various ways to integrate technology into the curriculum and provide instruction on how to use technology for productivity as well. The technology station is also available for teachers to use in their classrooms.

Year Two activities will conclude with two summer institutes. The Math Institute for Middle School (MIMS) in late June will focus on pedagogy and technology integration and the Elementary Math Summer Institute will be held in mid-July.

In Year Three of the CPD initiative, the Richard Stockton College of New Jersey will continue to build mathematical content knowledge, explore instructional practices and expand

the use of technology in the partner districts of Buena Regional and Atlantic City. Additions and enhancements to the year two cohort of participants will help to ensure that the CPD Model will have a systemic effect in each district. Continued articulation with the Office of Teacher Education will provide pre-service teachers with opportunities to interact with experienced classroom teachers and first-year teachers in partner districts will have access to mentors and programming designed especially for them.

The continued goal of the Customized Professional Development Model for Highly Qualified Teachers in Year Three is to provide sustained, high quality school based activities that will lead to improved student achievement in the New Jersey Assessment of Skills and Knowledge for grades three and four, the Grade Eight Performance Assessment, and first time scores of the High School Proficiency Assessment.

Memorandum of Understanding

For July 1, 2005 through June 30, 2006

The Educational Technology Training Centers were established by New Jersey Law [P.L.1996, c.129].

The mission of the Educational Technology Training Centers (ETTCs) is to provide ongoing, high quality professional development that is responsive to the educational technology training and curriculum integration needs of educators from all grade levels (K-12) in both public and non-public schools throughout the state. Training activities will be aligned with New Jersey's Core Curriculum Content Standards and pedagogies and instructional styles consistent with life-long learning and distance learning.

This Memorandum of Understanding seeks to clarify the roles, responsibilities and benefits for the Southern Regional Educational Technology Training Center (hereinafter "ETTC") and its lead agency, Richard Stockton College of New Jersey, (hereinafter "the lead agency") in collaboration with the Southern Regional ETTC Steering Committee and the member school districts of the Southern Regional ETTC Consortium.

If the ETTC program continues to focus on the above mission statement and the lead agency continues to support the ETTC in the manner described below in this MOU, then the ETTC will be approved or certified by the New Jersey Department of Education to continue as the designated ETTC for Atlantic County.

To be department approved, the ETTC program must continue to address the following components.

1. The Educational Technology Training Center (ETTC) name must continue to be used.
2. A "user-friendly" demonstration center must be maintained. The center should include computers, multimedia hardware, software, curriculum-related materials, access to distance learning, etc.; and should have signs designating it as the county ETTC.
3. A director/coordinator must be assigned to the program and be responsible for coordinating professional development, addressing needs for technical assistance and related activities at the ETTC. The director/coordinator must attend quarterly meetings as established by the department of education. No substantive portion of the scope of work may be subcontracted to an outside entity.
4. The primary target audience continues to be educators; however, workshops and other services may be provided to the larger learning community of parents, families, local businesses, community members, libraries, and other entities.

5. Evaluation data about educators participating in ETTC workshops and other training events must be electronically submitted quarterly to the Office of Educational and Informational Technology. (Such information may include number of workshops held, number of participants, and evaluation of workshops by educators.)
6. The ETTC web site must be maintained with training opportunities updated regularly. (The department's web site will link to the ETTC web site.)

Department approved ETTCs will enjoy the following benefits:

- Eligible for targeted state and federal funding opportunities as the department approved county ETTC;
- Direct assistance from the department in identifying potential private sector partnerships;
- Direct communication maintained with the department on key issues via e-mail, web site links and regularly scheduled meetings to ensure that the ETTCs receive timely information concerning major educational initiatives and potential resources;
- Continued statewide and national recognition initiated and promoted by the department.

This memorandum of understanding must be renewed annually and requires the signature of the lead agency's representative (CEO for the Southern Regional Institute and ETTC) and the Chair of the ETTC Steering Committee to demonstrate commitment to the ETTC mission and program components. When this document is fully executed, the lead agency is eligible for future grants and activities targeted for the ETTC program, if the funding source for the future grant program allows awards to institutes of higher education.

- WHEREAS,** in 1996 the College formed a Consortium that has now grown to 76 member organizations including public school districts, non-public schools, charter schools, colleges and non-profit organizations in Atlantic, Cape May, Cumberland, Monmouth and Ocean Counties; and,
- WHEREAS,** in 1997 the Consortium established the Atlantic County Educational Technology Training Center (ETTC) which had been housed at the College since its inception; and,
- WHEREAS,** the ETTC has provided exceptional training in educational technology and the NJ core curriculum content standards to K-12 educators, College faculty, staff, graduate students, and undergraduate students and received designation in 2002 by the New Jersey Department of Education as the Southern Regional ETTC; and,
- WHEREAS,** in 2004 the Southern Regional ETTC moved to its current location in the county seat of Mays Landing; and,
- WHEREAS,** the ETTC has provided over 3,000 training sessions to over 25,000 participants and received top reviews for workshop quality from 95% of participants; and,
- WHEREAS,** the ETTC is considered one of the premier K-12 teacher training institutes in New Jersey, and has brought renown to the College through honors such as the National Telecommunications Partnership Award, the Best Practices Academy for South and Central Jersey, and the Texas Instruments Regional Training Center for eight counties; and,
- WHEREAS,** the ETTC has provided a unique liaison function between the College and school districts for joint programs, and outreach to prospective graduate students, and has attracted thousands of visitors to the College; and,

- WHEREAS,** the ETTC has received grant awards from the National Endowment for the Humanities, the Verizon Foundation, the New Jersey Statewide System Initiative as well as several grants from the New Jersey Department of Education; and,

MANAGERIAL COMPENSATION PLAN

FISCAL YEAR 2006

Salary increases for managerial, exempt, and nonaligned professional employees shall be based upon an assessment of the employee's performance. All increases shall only be made upon recommendation of the President.

1. All managerial anniversary dates are July 1 following the initial year of hire.
2. A performance-based increase will be awarded to eligible employees as specified in the schedule of performance-based evaluations set forth below.
3. Evaluations will be conducted in the year preceding the award of a performance-based compensation increase on the following schedule:
 - a. first through fifth year managerial employees will be evaluated in the normal schedule; and
 - b. managerial employees scheduled for multiyear evaluations will be evaluated during the June cycle.
4. The total amount of performance-based compensation eligible for award to managerial employees shall be in accordance with the compensation schedule for managerial employees, which is set forth in the following schedule.

Eligible managerial employees shall, as of July 1, 2005, receive an across-the-board adjustment of 3.00% annualized, and a performance-based increase in current base salary of an amount equal to the value of an increment in their current salary range, not to exceed the maximum of the range.

SUBJECT: Resolutions Pertaining to Construction Initiatives

Several construction initiatives will be presented to the Board of Trustees at the June 15 meeting. The Resolutions and Construction Review and Approval forms are enclosed. I have provided a brief explanation of the reason for budget increases below.

- The *F-Wing Extension and Renovation* project requires a budget increase because of significant increases in the cost of construction materials, a more accurate estimate based on a detailed final document, and provision of a final cost allowance for furniture and telecommunications.
- The *Aquifer Thermal Energy Storage (ATES) System* has a higher than normal contingency due to the uncertainty of dealing with an international firm and likely complications that may arise from using an international firm and uncommon technology with limited qualified vendors.
- The *Lake Fred Spillway Repairs Budget Increase* requires additional funds because the actual bids received were higher than the estimated amount. Sixty percent of the cost for this project, necessitated by storm damage, will be reimbursed by the insurance carrier.

Funds are also requested for the following projects.

- *Housing 1 Interior Renovation*, which will restore the furnishings and update the interiors in that section of student housing.
- The initial phase of the *College Center* project requires funds for the design and administrative services for the Center. The design team will provide a concept design and detailed cost estimates for the project.



"VERIZON" BUILDING PURCHASE & J-WING RENOVATION

Project Overview:

- Total budgeted amount for the "Verizon" Building purchase, renovation to house 39 individuals currently in J-Wing, plus renovation of Upper J-Wing to faculty offices - \$4,000,000.
- The Internal Audit Function (Emily Vu) will remain on Campus and relocated to J-203.
- Funds remaining after the "Verizon" Building purchase - \$731,319.
- Proposed renovation of the "Verizon" Building - \$310,000. This will include the installation of 25 cubicles for personnel occupancy. The cubicles walls will be 65 inches high and will be equipped only with a workstation which is integral to the cubicle itself as the partitions are not self supporting. Overall approximately 80% of all the existing furniture in Upper J-Wing will be re-utilized in the "Verizon" office space.
- The vacated Upper J-Wing area will be renovated to house 27 faculty offices. The space will be occupied by current faculty to be relocated from Upper K-Wing and new tenured track professors. The budget available for this work is \$421,319 although the overall cost for the area modification to faculty offices is estimated to be \$211,000.
- The remaining \$210,319 after the Upper J-Wing renovation could be applied to the redesign of the area currently occupied by Purchasing and Accounts Payable in Lower J-Wing. Possible new use of the area will be for 11 additional faculty offices or classrooms and needed.

The "Verizon" Building purchased in March of 2005 is a single-story office building formerly used and set-up for IT services (approximately 50% of the floor space is raised floor to house communication cables). The building interior houses 14 stationary walled offices (sheet rock walls, floor to ceiling), including two conference rooms and one large lunchroom area. The remaining floor space (raised floor) is wide open and was formerly set up with individual office cubicles. The furniture and office partitions left behind by the former tenant are broken and mismatched which are not suitable for re-assembly.

The proposed plan to relocate 39 RSC employees from J-Wing to this facility is as follows:

1. Fourteen (14) employees assigned occupy the permanent offices in the "Verizon" Building will relocate with their existing furniture (desks, chairs, bookcases, file cabinets, etc.).
2. The remaining 25 employees will be housed in new cubicles which will consist of partitions 65 inches high and a workstation surface suitable for their PC. These employees will bring their chairs, cabinets, and any other office items from their J-Wing offices. The justification and advantages and disadvantages of this proposed layout are as follows:
 - The raised floor construction offers a number of advantages for the installation of power lines and communication cables, however it negates the possibility of installing any additional permanent walls for new individual offices.
 - The current HVAC layout has been designed and constructed for heating and ventilation of an open area with limited number of permanent offices. System redesign and ductwork modifications will be expensive and time consuming if we elect to install floor to ceiling office partitions.
 - The proposed modular cubicles are pre-wired for power, making expensive and time consuming electrical modifications unnecessary. ***This will also allow the College to avoid the need to obtain professional engineering services for a major electrical permit which could delay the occupancy by a minimum of two months.***
 - The office cubicles are easily modified and can be relocated in the event the current office floor set-up needs to be rearranged due to changes in occupancy or use. Their compact design allows additional units to be added in the available floor space for future occupancy if needed, which will conversely result in additional faculty offices or classrooms on Campus.
 - The primary disadvantage of this office layout is the lack of privacy the cubicles offer. The partitions only reach up to 65 inches high, lower for secretarial units and do not have doors.

Overall, approximately 80% of the office furniture currently in use in upper J-Wing will be relocated to the "Verizon" Building. This furniture includes all chairs, filing cabinets, conference room tables, credenzas and multi-purpose tables such as the ones be used for the Blueprint room and lunchroom

Once the administration staff is relocated to the "Verizon" Building from Upper J-Wing, the entire area will be converted to faculty offices. Altogether 27 offices will be constructed and furnished with new furniture. In addition 11 more offices will be constructed in the area currently occupied by Purchasing and Accounts Payable in Lower J-Wing. The faculty occupying these offices will include 8 current faculty members relocated from K-Wing and most of the anticipated tenured track professors to be hired over the next few years.

The budget for Upper J-Wing renovation includes \$68,000 for new furniture for faculty. It also includes professional architectural services as construction permits will be necessary for egress issues and electrical and fire protection modifications.
