The Stockton Emergency Operations Plan exercise was held on May 24, 2007 with the assistance of the Ocean County Office of Emergency Management. Stockton served as a reception center for the simulated evacuation of 10,000 southern Ocean County students as the result of a *staged* emergency at the Oyster Creek Nuclear Plant. The Department thanks all who participated in this full scale exercise, especially the CERT volunteers who were instrumental in facilitating this drill.

The Department continues to work on improving emergency preparedness on campus and is working with the Division of Student Affairs to prepare an Emergency Procedures Guidelines book for the College community. It should be ready before the start of the fall semester and will be available in hard copy and on-line.

FACILITIES PLANNING AND CONSTRUCTION

Alton Auditorium

The architectural firm, Farewell, Mills and Gatsch (FMG), provided the College with Schematic Design estimates, and began the Design Development Phase in June. It is anticipated that construction will commence in January 2008 with a completion date of October 1, 2008.

Aquifer Thermal Energy Storage (ATES) System

The lowest responsible bidder, Stockton Mechanical Contractors, Inc., was awarded a contract for this project. The drainage swale beside Parking Lot #1 was judged by our Architectural Engineer (A/E) and Marathon Engineering to be unnecessary. Pavement between parking lots will be removed to comply with the Pinelands Commission requirement to offset increased manifold house roof run-off. Marathon will prepare a submission to Pinelands. Three (3) project meetings have been held and the project is on schedule.

Building 30 Standby Generator

The contractor received detailed technical objectives for the development of change orders to provide annunciator alarm contacts, their tie-in to the campus system, and the associated interface cabling serving the standby and emergency generators at Building 30. The engineer

has provided an estimated construction cost of the remaining necessary change orders beyond the assigned project budget. The Office of Facilities Planning & Construction will request additional funding to complete the project.

Campus Center

The Design Team has had several meetings with various College divisions to review and collect information on the building layout and to discuss and review the building's HVAC system. The agreed upon system uses the existing geothermal system as the primary HVAC system for the building. The geothermal system will be supplemented by the new (ATES II) system which is currently under construction. The proposed system will require the replacement of the existing air handling units on H, J, I, and the old F-Wing, with a split air handling unit that would allow the new replacements to be retrofitted to the ATES II system. Several issues, such as finalization of the building's roof aesthetics, elevations and food service still need to be resolved.

Campus Fire Alarm & Detection System

The first phase of this project entails the replacement of the fire alarms and carbon dioxide detectors in Housing I. The initial work will include a new command monitoring system located at the Police dispatcher's office. The construction phase of this project was awarded to Delta Line Construction and is scheduled to commence in July 2007 with a planned completion date prior to the fall 2007 semester.

Environmental Assessment, Site and Utility Surveys

Marathon Engineering & Environmental Services, Inc. is continuing with the College-wide environmental assessments. They are currently concentrating on the Pinelands submittals and Treatment Works Application (TWA). The TWA will require approval from Galloway Township, Atlantic County and the New Jersey Department of Environmental Protection. As required for Pinelands Commission compliance, the engineer has also initiated a College-wide Threatened and Endangered Species Study and a College-wide Storm Water Management Study.

Holocaust Resource Center Addition

In addition to the renovation of the existing Holocaust Resource Center, this project also includes renovation/addition to the existing Graduate Office Suite in a portion of the Library's Late Study Area. The College has asked the architect's engineer to perform an air volume analysis and balancing in the Graduate Office Suite. This project is currently in the code review process at the New Jersey Department of Community Affairs.

Housing V, Phase II

The footings, foundations and all well drilling are complete on all buildings and the College has received all the necessary permits. Framing of the prefabricated panels has begun and completion will take approximately 21 days per floor. All work on the prefabricated panels will be coordinated to overlap and the work force will increase each week.

Internet Café

Contracts for construction were signed with the lowest responsible bidder, Axios Inc., in March. This project will be pre-fabricated off-site and installed in the F-Wing Gallery in late June. There has been a delay in the project due to the long lead time for delivery of materials that were unanticipated at the onset of this project. Completion is still anticipated for August 2007, however.

Mammoth HVAC Unit Replacement F Wing

A meeting was held with Concord Engineering to plan the construction schedule and discuss design concerns, such as interruption of the laboratory's scheduled use. It is anticipated that the construction phase of this project will commence December 2007, with a completion date during winter break of 2007-2008. This project is currently in the Design Phase.

Nacote Creek Rehabilitation & Upgrade

A contract between Stockton and the Gibson/Tarquini Group was executed in March. The Design and Program Development phases and preliminary code review are underway.

Northeast Telecommunications Upgrade

The College has received the signed and sealed drawings by the A/E, Morris Johnson. In June a construction contract was awarded to the general contractor, Avaya of Basking Ridge, New Jersey. This project will replace outdated telecommunications in the northeast portion of the campus.

Parkway Building Roof

A construction contract was awarded in June to the lowest responsible bidder, Alper Enterprises, Inc. Once permits have been received by the contractor from the New Jersey Department of Community Affairs, construction will commence. It is anticipated that this project will be complete during fall 2007.

Satellite Dish Replacement and Repairs

This project was successfully completed on time and within budget at the end of March. The College is still waiting for the Certificate of Occupancy from the New Jersey Department of Community Affairs. Once received, the College will make the final payment to the contractor.

Through the collaboration of The Richard Stockton College of New Jersey's Southern Regional Institute, the Southern Regional Educational Technology Training Center, and the Office of Teacher Education the college has offered school-based, high quality professional development activities to teachers in Wildwood City Schools and Somers Point School District during the 2006-2007 school year. These activities were designed to: 1) increase teachers' knowledge and instructional skills in the core content area of mathematics; 2) increase the number of skilled and experienced mentor teachers in the partner schools; 3) increase the number of pre-service teachers engaged in high-quality, standards-based professional development through opportunities to work under the guidance of experienced teachers and college faculty; and 4) increase teachers' knowledge of the use of computers and other technology to enhance classroom instruction and student learning.

The Year One Cohort included all special education, resource room, and basic skills teachers in grades K-5 at the Glenwood Avenue School in Wildwood and from the Jordan Road School, Dawes Avenue School and New York Avenue School in Somers Point. Also included in the Year One Cohort were several special education teachers from the Wildwood Middle School. To date, these thirty-eight teachers have received professional development organized around the five strands of the New Jersey Mathematics Content Standards. The workshops, delivered by Stockton faculty, were supplemented by weekly visits to each building by a coach/mentor, and workshops and activities to guide teachers in the development and integration of technology into their classrooms.

In Year Two, college faculty will return to each district to work with a new cohort of teachers. The project will provide teachers, administrators, paraprofessionals, and pre-service educators with a greater knowledge and understanding of mathematics content and pedagogy which are vital to student achievement in the New Jersey Core Curriculum Content Standards.

The continued goal of the Customized Professional Development Model for Highly Qualified Teachers in Year Two is to deliver the program model to a second cohort from each district in order to sustain the improved student achievement that has been reported by participating teachers in Year One.

- WHEREAS,** the ETTC provides a unique liaison function between the College and regional school districts for joint programs, and outreach to prospective graduate students, and has attracted thousands of visitors to the College; and,
- WHEREAS,** the ETTC is considered to be one of the premier teacher training institutes in New Jersey and has received more national and state honors and grant awards than any other New Jersey ETTC; and,
- WHEREAS,** the ETTC generates resources for operation through grant commitments, school district membership fees, and other revenues; and,
- WHEREAS,** the New Jersey Department of Education has designated the Richard Stockton College of New Jersey as the ETTC's Lead Agency for organizational and fiscal purposes; and,
- WHEREAS,** The College's faculty and staff shall continue to have access to ETTC training at no cost; now, therefore, be it
- RESOLVED,** that the Board of Trustees approves the Educational Technology Training Center Memorandum of Understanding between the Richard Stockton College of New Jersey and the New Jersey Department of Education, which shall be reviewed on an annual basis.

Memorandum of Understanding

July 1, 2007 through June 30, 2008

The Educational Technology Training Centers were established by New Jersey Law [P.L.1996, c.129].

The mission of the Educational Technology Training Centers (ETTCs) is to provide ongoing, high quality professional development that is responsive to the educational technology training and curriculum integration needs of educators from all grade levels (K-12) in both public and non-public schools throughout the state. Training activities will be aligned with New Jersey's Core Curriculum Content Standards and pedagogies and instructional styles consistent with life-long learning and distance learning.

This Memorandum of Understanding seeks to clarify the roles, responsibilities and benefits for the Southern Regional Educational Technology Training Center (hereinafter "ETTC") and its lead agency, Richard Stockton College of New Jersey (hereinafter "the lead agency") in collaboration with the Southern Regional ETTC Steering Committee and the member school districts of the Southern Regional ETTC Consortium.

If the ETTC program continues to focus on the above mission statement and the lead agency continues to support the ETTC in the manner described below in this MOU, then the ETTC will be approved or certified by the New Jersey Department of Education to continue as the designated ETTC for Atlantic County.

To be department approved, the ETTC program must continue to address the following components.

1. The Educational Technology Training Center (ETTC) name must continue to be used.
2. A "user-friendly" demonstration center must be maintained. The center should include computers, multimedia hardware, software, curriculum-related materials, access to distance learning, etc.; and should have signs designating it as the county ETTC.
3. A director/coordinator must be assigned to the program and be responsible for coordinating professional development, addressing needs for technical assistance and related activities at the ETTC. The director/coordinator must attend quarterly meeting as established by the department of education. No substantive portion of the scope of work may be subcontracted to an outside entity.
4. The primary target audience continues to be educators; however, workshops and other services may be provided to the larger learning community of parents, families, local businesses, community members, libraries, and other entities.

5. Evaluation data from educators participating in ETTC workshops and other training events must be electronically submitted quarterly to the Office of Educational Technology. (Such information may include number of workshops held, number of participants, and evaluation of workshops by educators.)
6. The ETTC web site must be maintained with training opportunities updated regularly. (The department's web site will link to the ETTC web site.)

Department approved ETTCs will enjoy the following benefits:

- Eligible for targeted state and federal funding opportunities as the department approved county ETTC;
- Direct assistance from the department in identifying potential private sector partnerships;
- Direct communication maintained with the department on key issues via e-mail, web site links and regularly scheduled meetings to ensure that the ETTCs receive timely information concerning major educational initiatives and potential resources;
- Continued statewide and national recognition initiated and promoted by the department.

This memorandum of understanding must be renewed annually and requires the signature of the lead agency's representative (CEO for the Southern Regional Institute and ETTC) and the Chair of the ETTC's Steering Committee to demonstrate commitment to the ETTC mission and program components. When this document is fully executed, the lead agency is eligible for future grants and activities targeted for the ETTC program, if the funding source for the future grant program allows awards to institutes of higher education.

Tuition Reimbursement for Spouses, Dependents,

Couples in a Civil Union and Domestic Partners

Policy # 114**Adopted May 2, 2007****Employees
Covered**

All full-time employees of the Richard Stockton College of New Jersey are covered by this policy. Spouses, legally joined partners in a civil union, legally joined domestic partners, and dependents as defined in New Jersey Statutes are eligible. However, a student eligible for reimbursement under this program shall be a matriculated full-time student enrolled in an undergraduate program of instruction at the College. Part-time students are not eligible for tuition reimbursement under this program.

Policy

- 1.1 Subject to limits to the program set forth below, reimbursement shall be no more than 50% of the tuition charged to and actually paid by or on behalf of the student, upon written proof to the Bursar that the semester's academic program has been satisfactorily completed.
- 1.2 The Office of Human Resources will verify the dependency of the employee and the Bursar shall verify the information provided by the student. Upon verification the Bursar shall direct the student be credited for the following semester or issued a reimbursement check for tuition.

Eligibility

- 2.1 A student's eligibility for tuition reimbursement is limited to five years from the time he or she becomes a full-time undergraduate student at the College.
- 2.2 No student who is a dependent will be eligible for tuition reimbursement if they have attained the age of twenty five years at the time of the beginning of the semester for which he or she seeks reimbursement.
- 2.3 Tuition reimbursement will be paid for only those persons who have received passing grades for enrolled courses.
- 2.4 A dependent, spouse, person in a civil union or domestic partner shall not be eligible for tuition waiver during the summer session.

Limitations

- 3.1 The overall amount allocated to this Program shall not be more than \$100,000 each year.
- 3.2 In the event the total amount of requested tuition reimbursement under this Program exceeds the overall limitation amount in any year, the total amount available shall be equally paid to all eligible students even though the reimbursement shall be less than 50%.
- 3.3 Reimbursement for tuition for courses taken prior to the Fall Semester, 2004 shall not be made.
- 3.4 All students eligible for participation in this Program must meet all academic requirements established by the College for initial admission and continuation at the College. Further, a student shall be required to be in good standing at the College.
- 3.5 The student shall apply for any and all appropriate financial aid through scholarship and/or grant before requesting tuition reimbursement under this Program. If the student receives financial assistance, he or she will be eligible for up to 50% of the remaining balance of tuition charged and paid by him or her, or paid on his or her behalf. Student loans, if any, shall not be considered an offset against tuition for the purpose of this program.

Death of Employee

- 4.1 In the event of the death of an employee who has a spouse, partner of a civil union, domestic partner or dependent enrolled at the College, at the time of his or her death, that student so enrolled shall continue in the tuition reimbursement program as if the person had not died.
