Athletic Fields at Pomona Road

The Design Phase of this project continues to progress. Construction is scheduled to begin in June 2008.

Alton Auditorium Renovations

The construction portion of this project was awarded in April. Construction is anticipated to begin in May 2008 with a completion date of December 2008.

ATES

The system is complete and operating, as weather permits. Final testing was done the end of March. Enhanced metering and communication links are being installed to facilitate energy efficient research.

Buildings 30, 31 & 32 HVAC Rooftop Units Replacement

This project consists of the replacement of all rooftop HVAC units on Buildings 30, 31 & 32. The project has been successfully bid and is scheduled to commence May 2008 with completion in August 2008.

Campus Center

The construction portion of this project was recently advertised for bid. The project's construction has been split into two (2) phases in order to establish an orderly and efficient schedule. The phases include the following:

Phase I Site Development:

This phase of work will encompass the preparation of the site for the footprint of the new building and staging areas. This phase will include installation of gas, electric, sewer, and storm water utilities required to support the new structure. Site plan is on agenda for approval by Pinelands Commission. Code review and permitting for Phase I of this project is submitted to the New Jersey Department of Community Affairs (NJDCa). The construction phase of the project is scheduled to commence May 2008. A construction contract has been awarded.

Phase II:

This phase of the project will encompass the actual construction of the building. Construction documents for the New Jersey Department of Community Affairs code review and permitting submittal are scheduled to be ready June 2008. It is anticipated that construction of the Campus Center will commence November 2008.

Computer Center HVAC Rooftop Units Replacement

The project consists of the demolition of the existing Computer Room air-conditioning unit and the roof-mounted condensing fan unit. Additionally, this project includes the installation of two (2) new Computer Room air-conditioning units, roof-mounted condensing units, one (1) energy recovery unit and all related accessories.

A construction contract was awarded in late April.

Fire Alarm Detection System Replacement

The fire alarm systems in Housing II and III are obsolete and are scheduled to be replaced during summer 2008. The project is currently out for bid.

Free-To-Be Playground Equipment Upgrade

This project is currently in the Design Development Phase. In addition to bringing Free-To-Be playground into compliance under the Playground Safety Subcode, the project will be reviewed and licensed by the State of New Jersey, Department of Children & Families, Office of Licensing, Child Care Centers. Construction is scheduled to commence in July 2008.

Holocaust Resource Center Addition

A construction contract was awarded in late April. Construction will begin in May 2008 with a completion date of December 2008.

Housing V – Phase I

The contractor continues with the installation of floor tiles, sheetrock, paint, dampers, ductwork, heat pumps, plumbing and electrical items. Installation of doors, frames and casework for Building 120 has begun. The contractor is approximately 95% complete for the two (2) buildings.

Housing V- Phase II

The installation of the vapor barrier, exterior insulation, electrical rough-ins, plumbing rough-ins, sheetrock, ductwork, and interior insulation continues. Construction is 40% complete for the two (2) buildings.

Housing V - Reforestation

Reforestation has commenced and will be completed spring 2009. Coordination between Plant Management and Facilities Planning and Construction is taking place regularly regarding types and times of planting.

Nacote Creek Rehabilitation

Construction documents are complete and have been submitted for code review with the New Jersey Department of Community Affairs (NJDCa). The project is forecasted to be bid for construction in June 2008.

New Jersey Trails Grant (Bicycle Way-Finding Signage)

Exterior sign material specifications have been reviewed by the College. Design proposals, as well as the location for sign posts and quotes for sign posts, and their associated hardware will be submitted and reviewed.

Wayfinding

The design for campus-wide wayfinding has been completed. Review of this project has taken place between President Saatkamp, Departments of Buildings & Grounds along with the Departments of Facilities and Plant Operations. A schedule for the bid and implementation of Phase I of the wayfinding package (monuments and parking signage) will be developed in June 2008.

STUDENT AFFAIRS

OFFICE OF ATHLETICS AND RECREATION

The Stockton men's basketball team, coached by **GERRY MATTHEWS**, Head Men's Basketball Coach, won the New Jersey Athletic Conference championship for the fifth time overall and first since 1997. The Ospreys earned an automatic bid to the NCAA Tournament, where they defeated Immaculata University and Rhode Island College to advance to the NCAA Tournament sectionals for the first time since 1999. Stockton was eliminated from the NCAA Tournament by defending national champion Amherst College and finished the season with a 22-7 record.

The Stockton softball team, coached by **VAL JULIEN**, Head Softball Coach, registered a 13-3 record in its first 16 games of the 2008 season. The Ospreys played 10 games in Fort Myers, Florida during spring and posted a 9-1 record during the trip.

The Stockton baseball team, coached by **MARTY KAVANAGH**, Head Baseball Coach, began the 2008 season with a 14-5 overall record and a 2-2 mark in New Jersey Athletic Conference games. The Ospreys played nine games in Cocoa Beach, Florida during spring break and went 8-1 during the trip.

The Stockton lacrosse team, coached by **DICK RIZK**, Head Lacrosse Coach, posted a 5-4 record in its first nine games of the 2008 season. The Ospreys defeated Catholic University, Plymouth State College, Centenary College, DeSales University and Susquehanna University.

The Stockton men's outdoor track & field team, coached by **BILL PRESTON**, Coordinator of Cross Country and Track & Field, and the Stockton women's outdoor track & field team, coached by **TODD CURLL**, Head Women's Track & Field Coach, began the season by hosting the Stockton Invitational on March 22. The Ospreys also competed in the Danny Curran Invitational at Widener University on March 29 and hosted the Osprey Open on April 4-5.

The Stockton women's rowing team, coached by **TOM HEWITT**, Head Rowing Coach, opened its 2008 season at the Occoquan Sprints in Virginia. The Ospreys finished third in the novice four and fourth in the varsity four.

The College Center purchased a new projector for the N-Wing Student Restaurant that was installed by **DONALD FAUST** of Media Services. The new equipment will enhance movies and other programs.

MARGARET SIMONS, Professional Services Specialist 4, developed a user survey to determine efficacy of the College Center's services. A total of 342 students completed a survey. **Ms. Simons** attended a "webinar" entitled "Writing Right for the Web" facilitated by the Office of the Vice President for Student Affairs.

JOSEPH LIZZA, Assistant Director of the College Center, attended the National Association for Campus Activities Annual Convention, February 15-20, in St. Louis, MO. **Mr. Lizza**, along with **THOMAS O'DONNELL**, Assistant to the Dean of Students, and **LAMOTT MOORE**, Director of Student Development, presented "How Five Schools in New Jersey Collaboratively Partnered to Produce an Event" based on their article published in *Campus Activities Magazine*, October 2008.

Mr. Lizza and **JENNIFER FORMAN**, Assistant Director of Student Development, chaperoned a sold-out bus trip for students to a Philadelphia Flyers ice hockey game on March 4. A second bus trip to a Philadelphia 76ers game on April 8 was arranged and sold out within days. Both trips were cosponsored by the Office of the College Center and the Office of Housing and Residential Life.

Mr. Lizza attended the Alternative Spring Break program, March 15-22, in Sumter, South Carolina. The 17 student volunteers and three staff members including **Mr. Lizza**, **Ms.**

Forman, and Stockton Police Officer **LINDA KENNY** spent the week constructing homes with other Habitat for Humanity volunteers.

Mr. Lizza and his student staff oversaw a successful Thursday Night Movie series with an average attendance of between 20 and 25 students. The showing of *Sweeney Todd* on March 27 had the largest audience, about 60 students.

The College Center planned a variety of free programs open to all Spring 2008 graduating students. All events are cosponsored by the Office of the College Center and the Office of Housing and Residential Life. The programs for graduates include a charter bus trip to a baseball game, a catered dinner, bowling at Strike Zone, and "Dinner and a Movie".

OFFICE OF ENROLLMENT MANAGEMENT

Admissions' final Open House for the 2007-2008 academic year was held on March 2 with 1,087 students and their families in attendance. Students now get to pre-register for the event (319 with 464 guests) although a good number of students simply show up (84 with 220 guests).

Over 600 new scholarship students and their parents were invited to the first-ever Stockton Scholars Reception on March 18 hosted by the Office of Enrollment Management. The class of 2012 was provided opportunities to engage faculty, staff and future classmates, and the chance to learn everything they would need to know about their future at Stockton College. More than 400 guests attended and seven deposits were received on-the-spot, with many more during the ensuing week. As of April 3, 167 scholarship students have confirmed their intention to enroll for Fall 2008.

The Office of Enrollment Management hosted six Transfer Instant Decision Days during the spring semester. The programs averaged between 26 - 32 students per event. After receiving an admissions decision, students went to Academic Advising for an instant credit evaluation. A number submitted their acceptance deposits the same day; most expressed their future intent to enroll.

- WHEREAS,** the New Jersey Department of Education released a Notice of Grant Opportunity that provides continuation funding for the college's current Math and Science Partnership Grant; and
- WHEREAS,** the Richard Stockton College of New Jersey has successfully implemented a Math and Science Partnership Grant during the 2007-2008 academic year that conducts professional development activities in the core academic areas of mathematics, science and technology in order to ensure that teachers in Grades 3-8 have the subject matter knowledge in the academic subjects they teach, and in computer-related technology to enhance instruction; and
- WHEREAS,** the Richard Stockton College has collaborated on several successful initiatives with the K-12 community including the development of a regional consortium that has grown to 86 member organizations including public school districts, non-public schools, charter schools, colleges and non-profit organizations in Atlantic, Cape May, Cumberland, Monmouth and Ocean Counties; and
- WHEREAS,** at the request of several high needs but diverse school districts - Pleasantville, Woodbine, Egg Harbor Township, Buena Regional, Stafford, and Northfield— a proposal was developed to form the South Jersey Coastal Consortium (SJCC) to address the Year Two requirements of the Mathematics and Science Partnership Program; and

PROJECT ABSTRACT Mathematics and Science Partnership Yr 2/3 "South Jersey Coastal Consortium"

The Richard Stockton College of New Jersey (RSCNJ) has designed a three year plan that will provide three (3) eligible high-need local education agencies, and three (3) schools struggling to maintain consistent science and math test scores with tools to promote student achievement and comprehensive professional development activities to yield "highly qualified" teachers in the content areas of math and science in grades three to eight. It is anticipated that the Year Two Cohort will include 55 participants from 6 partner districts. Year One participants will be strongly encouraged to participate in Year Two activities.

A specifically designed graduate course from the Master of Arts in Education (MAED) and Master of Arts in Instructional Technology (MAIT) Programs at the college will provide content knowledge and pedagogy as well as strategies for the use of technology in the classroom to participating teachers during a two-week summer institute that will focus on topics in physical science and the mathematics used to increase understanding within that scientific field. In Year Two participants will gain an understanding of natural laws as they apply to motion, forces and energy (New Jersey Core Curriculum Content Standard 5.7). Utilizing the college's geothermal HVAC system, one of the world's largest single closed loop geothermal systems as a living textbook, participants will learn that the flow of energy drives processes of change in all biological, chemical, physical and geological systems. Wind, solar and alternative energies will be explored and field trips will include a visit to the Jersey-Atlantic Wind Farm in Atlantic City which consists of five state-of-the-art "windmills" reaching 380 feet in the air. Project activities will continue throughout the school year and will include onsite professional development, in-class coach mentoring, opportunities to learn from practitioners in the community, and use of web-based distance learning technologies.

Program evaluation will include an analysis of student achievement data from partner districts to determine improvements that may have occurred because of teachers' participation in the project. Observations conducted during the summer institute will assess the effectiveness of the program delivery and provide a context that can be used for continuous program improvement.

Using the natural environs of the coastal region as a backdrop, the South Jersey Coastal Consortium will guide participating teachers through an exploration of mathematics and science topics that will enrich their knowledge and understanding of the content and enhance their teaching skills, ultimately leading to improved student achievement.
