#### **Campus Center**

Construction of the Campus Center building has commenced. Construction trailers for the Construction Management firm, as well as the General Contractor are in place on site. The building's structural permit has been received from the New Jersey Department of Community Affairs (DCA). The footings are nearing completion. Upon receipt of the DCA permits for the next phase of the project, installation of underground utilities, as well as the concrete flooring will commence. Construction is scheduled for completion in 2011.

#### **L-Wing Adaptive Reuse**

The College hired an A/E to design the adaptive reuse/renovation of the L-Wing swimming pool area into academic and administrative space along with an art gallery. This project is currently in the concept design phase. It is anticipated that construction will begin in fall 2009 with a completion date of 2010.

#### **Analysis for Combined Heat & Power (Co-Generation)**

An SBE engineer was hired to provide the College with an analysis of a co-generation facility to produce combined heat and power. The initial report indicated the project is feasible.

#### **Unified Science Center**

A determination was made to divide this project into three phases of development and implementation. An architect has been retained and is working through programmatic issues with the College.

#### **Athletic Fields at Pomona Road**

Construction documents and specifications for this project are complete. Cape-Atlantic Soil Conservation is currently reviewing the College's application for this project. Once the necessary agencies have concluded their reviews and provided their approvals of the project, i.e. Cape-Atlantic Soil Conservation, Pinelands Commission and DCA, a contract will be issued to the contractor.

#### **C/D-Wing Courtyard Renovations**

The renovation of the underutilized C/D-Wing courtyard will transform this area into a program support space. This project is proceeding to the design phase.

#### **Nacote Creek Rehabilitation**

The project includes the demolition and reconstruction of Building #501 greenhouse and Building #503 prep/storage. A new septic field, potable water well, HVAC improvements and

miscellaneous exterior repairs are also included. Construction is underway and scheduled for completion in summer 2009.

#### **Signalized Intersection (Traffic Light)**

An engineer has been retained and has submitted a design for a new traffic signal at the intersection of Jimmie Leeds Road, and Vera King Farris Drive at the main academic entrance of the campus. The design includes technical design services for the planning and specification development to reconstruct the intersection and also the installation of a traffic signal and required right-of-way acquisitions, if required. Additionally, the design includes roadway widening, utility coordination, geometric revisions, drainage improvements, signage, resurfacing the intersection and the required environmental permits. This traffic signal will abate increasingly serious life/safety issues that currently exist at this intersection. Discussion and presentations with Atlantic County and Galloway Township have taken place.

#### **Off –Campus Single-Family Housing (SASI)**

Construction of three of the five houses is complete. The remaining two homes will be completed in summer 2009. The completed homes are ready for occupancy.

#### **Sports Center Photovoltaic**

This project is structured as a public/private partnership. The Independent Power Producer (IPP) has built, installed, owns, operates and maintains a photovoltaic (solar) array on the Sports Center roof. The College will purchase the electricity from the IPP at a predetermined long-term contractual price. The photovoltaic portion of the project is complete. Additionally, the contractor has retrofitted the Sports Center arena lighting with energy efficient lighting thus improving light levels and saving energy. The lighting portion of the project is expected to take place during the winter months. This system will be 318 Kw in size and produce approximately 390,000 kWh per year.

#### **Campus Reforestation**

Reforestation has commenced and will be completed during the planting season in spring 2009. Coordination between Plant Management and Facilities Planning & Construction took place regarding types and times of planting, as well as coordination with the contractor regarding maintenance of the plantings.

#### **Traffic Signal Timing on Jimmie Leeds Road**

Engineering services have been retained to provide a traffic study to determine the best traffic signal coordination for Jimmie Leeds Road between Chris Gaupp Road and the Garden State Parkway intersection. The traffic signal timing adjustment would maximize gaps on Jimmie Leeds Road allowing safe maneuvering from side streets onto Jimmie Leeds Road. Atlantic County is assessing the proposed adjustments and will implement during the spring 2009.

#### **Lakeside Center Lodge Kitchen**

The kitchen area at the Lakeside Center Lodge will be converted into a Pizza Express, as well as remediate the kitchen's ventilation system. An architect and engineer have been retained to design this project. Currently, the project is in the design phase.

#### **Housing IV Swimming Pool Feasibility Study**

An architect has been retained by the College to conduct a preliminary feasibility study to determine the impact of installing an in-ground pool in the Housing IV area that would contain mechanical equipment, equipment/chemical supplies and a changing area. Once the architect

has completed the study, the College will be able to forecast annual operation and maintenance costs.

#### **Plant Management Storage Facility**

The existing small and outdate storage shed will be removed in Plant Management's storage yard and replaced with a pre-engineered storage facility. The project will include consolidating several existing storage sheds into one improved storage facility which will provide additional security for stored items.

#### **Campus Entrance Signage**

A Request for Proposal (RFP) is being developed that will incorporate the scope of this project which will include six new signs. The signs include one at the main entrance, three monument signs and two LED signs that will be utilized for posting college activities, special events and police emergencies. It is anticipated that the RFP for this project will be advertised in late spring.

#### **Parking Lot #7 Photovoltaic Array**

This project is structured as a public/private partnership. The Independent Power Producer (IPP) has built, installed, owns, operates and maintains a photovoltaic (solar) array in Parking Lot #7. This system is 378 Kw and will produce approximately 445,149 kWh per year. The College will purchase the electricity from the IPP at a predetermined long-term contractual price. The photovoltaic portion of the project is complete. This array will defray the College's cost of electrical power and will exemplify the College's ongoing commitment to going GREEN.

#### **OFFICE OF PLANT MANAGEMENT AND HOUSING MAINTENANCE**

The Department of Plant Management and Housing Maintenance continues to support daily maintenance operations, supports numerous events including student, athletic and community based programs, initiates and manages campus-wide renewal and renovation projects and schedules and maintains regulatory compliance for the College.

#### **Campus Maintenance & In-House Projects**

Completed a renovation of the Parkway building which allowed for reconfiguration of purchasing personnel.

Coordinated efforts to replace damaged switchgear as a result of wind storm on February 12, 2009.

Replaced emergency transfer switchgear in Building 30 and Buildings 75. This replacement was necessary to improve emergency systems performance. Improvements were also made on the Building 30 Fire Alarm Systems due to performance problems.

Completed an entrance facade upgrade for The School of Graduate and Continuing Studies. Upgraded the lighting in the stage area of the Performing Arts Center.

#### **Housing Maintenance & In-House Projects**

Completed an electronic locking system upgrade for Housing 4. Converted from standard mechanical-keyed system to an electronic access system.

Oversaw the completion of Housing 5 punch-listed items which addressed minor problems with the building envelopes.

Spring Break Safety Tips, including information about preventing sexual assault and dating violence, were distributed to students at information tables during the week of March 9, 2009. During the week of March 9, 2009, Stockton celebrated its **2<sup>nd</sup> Annual Disability Awareness Week**. This was a collaborative and cooperative effort among faculty, staff, students and several community organizations. On March 14, 2009, **ROBERT ROSS**, Assistant Director Learning Access Program, acted as school ambassador and assisted at the 2009 F.A.C.E.S. Autism Conference: Arts, Abilities and Autism. The mission of F.A.C.E.S. (Families for Autistic Children Education & Support) is centered on early intervention, education, advocacy, and support for families affected by Autism Spectrum Disorder in the South Jersey area.

A general interest meeting for Active Minds on Campus was held on March 24, 2009. Active Minds is a peer to peer organization that aims to raise awareness about mental health issues and provides college students with accurate information about mental illnesses.

The proceeds this year benefited South Jersey AIDS Alliance. **"South Jersey Coastal Consortium"**

The Richard Stockton College of New Jersey (RSCNJ) has designed a three year plan that will provide three (5) eligible high-need local education agencies, and three (2) schools struggling to maintain consistent science and math test scores with tools to promote student achievement and comprehensive professional development activities to yield "highly qualified" teachers in the content areas of math and science in grades three to eight. It is anticipated that the Year Three Cohort will include 50 participants from 7 partner districts and two non-public schools.

A specifically designed graduate course from the Master of Arts in Education (MAED) and Master of Arts in Instructional Technology (MAIT) Programs at the college will provide content knowledge and pedagogy as well as strategies for the use of technology in the classroom to participating teachers during a two-week summer institute that will focus on topics in earth science and the mathematics used to increase understanding within that scientific field. Continuous professional development will be provided to participants throughout the school year to support the introduction of new content and instructional strategies.

The scientific content to be explored in Year Three will be Earth Science, and more specifically, biogeochemical cycles. The emphasis on biogeochemical cycles will build upon the Year One exploration of life science and the Year Two exploration of physical science and energy transformation. Participants will learn how biogeochemical cycles are part of the larger cycles that describe the functioning of the whole earth. The understanding of biogeochemical cycles and the relationship to living systems will be the basis for developing possible solutions to environmental issues. Through problem-based learning activities participants will investigate the connection between biogeochemical cycles and environmental issues and will explore possible solutions to particular environmental challenges. As revised NJCCCS are reviewed and adopted, participants will be provided with the support they need to align existing district curriculum with the new standards.

Program evaluation will include an analysis of student achievement data from partner districts to determine improvements that may have occurred because of teachers' participation in the project. Observations conducted during the summer institute will assess the effectiveness of the program delivery and provide a context that can be used for continuous program improvement.



- WHEREAS,** since the Fall 2006 semester the College has established charges for tuition and credit-related fees for full-time graduate students that are capped at a rate equivalent to 15 credit hours per semester, notwithstanding that a particular graduate student may have enrolled in a course or courses in excess of the 15 hours per semester; and
- WHEREAS,** the School of Graduate and Continuing Studies has grown since 1997 to include eleven graduate programs and post-baccalaureate programs, and four certificate programs; and
- WHEREAS,** in terms of applications, student demand to enroll in Stockton's full-time graduate programs far exceeds the space available in each class or cohort; and
- WHEREAS,** the labor market continues to be strong for graduates of Stockton's full-time graduate programs in the health sciences, which are the programs that will be most affected by raising the cap on tuition and fee charges; be it
- RESOLVED,** that the Board of Trustees amends the policy for tuition and credit-related fees for graduate students that it adopted in a resolution dated July 9, 2008; and be it further
