### **Stockton Partners with FAA**

The Federal Aviation Administration Technical Center dedicated its new electronic classroom built in partnership with the Richard Stockton College of New Jersey. Based on the electronic classroom standard set by Stockton, members of the Computer and Telecommunication Services staff worked with employees of the FAA to plan, design, and implement this space. ### **Student Outreach Enhanced by Technology Services**

New services are available and undergoing testing to enhance Stockton's ability to reach out to new matriculated and continuing education students. In the **goStockton** Portal, the "Welcome" tab has been added for newly admitted undergraduates. The information they need prior to orientation and registration is available for them in a single location. To support continuing education, the Flexible Registration module for Banner has been installed in the test system. Once in production, this system will integrate continuing education courses into the Banner system and will facilitate course offerings that do not conform to the semester structure as well streamline registration and payment tasks with shopping cart functionality.

Thanks to this innovative locking solution, Stockton has significantly improved its readiness to an emergency and may be the only institution of higher education in New Jersey that can immediately lock down all academic class rooms with the pull of a switch from the police department's communications center.

## **FACILITIES PLANNING AND CONSTRUCTION**

### **Athletic Fields at Pomona Road**

Installation of the Electric Utility Building is complete. The grandstand bleachers are on site and being assembled. Since weather conditions have improved, the placement of the filter fabric and crushed stone base for the athletic field will commence. Installation of the synthetic turf has begun. Construction is anticipated to be completed spring 2010.

### **Campus Center**

Waterproofing of the exterior walls is complete. Cast stone, which surrounds the exterior of the Campus Center, is nearing completion. Roofing over the entire building is 95% complete and the window frames are onsite and being prepared for installation. HVAC ductwork, rough electric and rough plumbing are completed throughout half of the 1<sup>st</sup> floor and the installation of the wall boards for the interior of the building has begun.

### **Campus-Wide Signage**

The new directional sign has been fabricated and will be located at Pomona & Moss Mill Roads, near the entrance to the Garden State Parkway. All the signs were completed in March and the project has moved to the final punch list phase.

### **C/D-Wing Courtyard Renovation**

This project is part of the L-Wing Pool project and therefore, will be put out to bid along with the L-Wing Pool project. The design will be submitted to the New Jersey Department of Community Affairs for their review and permitting. It is anticipated that this project will be commence in fall 2010 with a scheduled completion date of fall 2011.

### **Clean Energy Audit Program**

The College has received the approval of the revised energy audit application from the Board of Public Utilities. The College will next issue a Request for Proposal from the pre-approved energy audit firms.

### **College Walk Reconstruction**

The architect has completed the Programming Phase of this project and has begun the Schematic Design Work for the College's review. Once the College has reviewed all the drawings, documentation and provided their approval, the architect will commence with the preparation of the plans and specifications. Following final preparation of the construction documents, they will be sent to the New Jersey Department of Community Affairs (NJDCA) for their review and approval. It is anticipated that this project will be put out to bid in fall 2010 with a scheduled completion date of summer 2012.

### **Field #4 Surface Parking**

An SBE engineering firm is under contract to provide site survey, geotechnical analysis and a parking plan to transform the practice field into a parking area. The temporary parking will be constructed in a way to allow the field to be returned to its original use. The project is expected to be bid for construction summer 2010.

### **50 West Jimmie Leeds**

A Request for Qualifications (RFQ) was issued in March to New Jersey Department of Property Management and Construction (NJDPMC) pre-qualified design/build firms. The College has received the RFQ's for this project and will next elicit a short-list the design/build firms. Once the short-listed firms have been established, the College will request they submit more detailed information addressing financing, programming, design and scheduling. It has been proposed that the new facility will accept occupancy by November 2011.

### **L-Wing Renovation**

Construction Project Documents are nearing completion. The College has hired a Construction Manager for this project to provide plan review and administrative services. Some modifications have been made to the drawings and they have been forwarded to the New Jersey Department of Community Affairs (NJDCA) for their review and permitting. Pending final approval by the NJDCA, the College anticipates this project going out to bid in late spring/early summer. With a projected 14-month construction schedule, this project is scheduled to be completed in early winter 2011.

### **Housing I, Housing V – North & West Parking Lots Photovoltaic Array**

At the current time, the College is finalizing contract terms with the New Jersey Board of Public Utilities.

### **The New Jersey Institute Alternative Test Bed Center**

The College is developing a Scope of Work for the cleanup of the main lodge and site on the property.

### **Regional Signage**

A regional survey of existing College signage was performed in December 2009. The Atlantic County Department of Engineering is offering support in developing new and improved campus/regional signage.

### **Signalized Intersection (Traffic Light)**

This joint Atlantic County/The Richard Stockton College of New Jersey project was approved by the Pinelands Commission in March. Tree trimming and removal of the parcel that parallels Jimmie Leeds Road and Duerer Street has begun. A Notice to Proceed has been issued to the General Contractor who will proceed with construction on Louisville Avenue, then will begin construction on Jimmies Leeds Road, Vera King Farris Drive and the Duerer Street intersections. Utility poles and wire will be relocated in May. Campus Police has been apprised of the construction activities and will provide traffic management, as required. It is anticipated that this project will be complete during summer 2010.

### **Unified Science Center**

The project is now in the Design Development Phase. A meeting was held with President Saatkamp, the architects and the Unified Science Center Committee to review the architect's renderings and current design status. The project will next move forward to the preparation of the construction documents.

### **OFFICE OF PLANT MANAGEMENT AND HOUSING MAINTENANCE**

The Department of Plant Management and Housing Maintenance continues to support daily maintenance operations, supports numerous events including student, athletic and community based programs, initiates and manages campus-wide renewal and renovation projects and schedules and maintains regulatory compliance for the College.

#### **Tracer ES Software Upgrade for Campus HVAC System**

The Tracer ES Software Upgrade allows for increased portability for technicians in the field to better maintain and troubleshoot the College's HVAC systems. The improved functionality and graphics provided by the software will eventually allow for occupants and users to remotely monitor room conditions.

#### **Building 41 (Big Blue) Locker Room Conversion**

Unused locker room/storage space in Building 41 was converted to a meeting room for athletic recruitment.

### **Parkways Building Renovation**

The Parkway Building was reconfigured to provide additional space for The Department of Risk Management & Environment/Health/Safety.

### **Office of Veteran Affairs Renovation**

A lounge space was created in upper G-Wing to accommodate Veteran students enrolled at the College.

### **Human Resources/Payroll Renovation**

Plant Management staff assisted in reestablishing Payroll in the J-Wing suite of The Office of Human Resources on the Main Campus.

As of March 25, 2010, 854 students at Stockton College had completed the survey (22.7% response rate) and over 22,000 students nationally had completed the survey (26.8% response rate).

**ABSTRACT**

The intent of the Cumberland Collaborative is to improve K-12 teachers' knowledge and pedagogical practices in the core content areas of mathematics and science, develop both intra-district and inter-district professional learning communities that will sustain the work begun through this initiative, establish communication and collaboration throughout the countywide system of K-12 education in order to facilitate the use of shared resources and shared services, assist teachers as they strive to prepare every student with the 21st century readiness skills of critical thinking and problem solving, communication, collaboration, and creativity and innovation, and support partner districts as they introduce and align the revised New Jersey Core Curriculum Content Standards with existing curricula.

Through a project team that includes faculty from the Richard Stockton College of New Jersey's School of Natural Sciences and Mathematics (STEM), the School of Education, the Southern Regional Institute and ETTC, faculty and staff from Cumberland County College, and administrators and teaching staff from the four largest school districts in Cumberland County, New Jersey, a three-year program of professional development activities will guide participating teachers through an exploration of topics in mathematics and science that will increase their individual and collective abilities to improve student achievement throughout the county. Participating school districts include Bridgeton Public Schools, Vineland Public Schools, Millville Public Schools, Cumberland Regional School District and one of its sending districts (Stow Creek).

STEM faculty will be paired with faculty from the School of Education to provide a "balanced" delivery of professional development and coursework which will enable the faculty pairs to address both content and pedagogy. Activities will include a two-week summer institute, in-service programs provided during the school year, classroom visits and observations by college faculty as well as science and math practitioners, the development of a virtual community in which all cohort members will be required to actively participate, and after-school workshops to introduce and enhance teachers' use of technology.

The content provided each year to a new cohort of teachers from partner districts will adhere to the required topics outlined in the Notice of Grant Opportunity published by the New Jersey Department of Education. Mathematical Processes and Science Practices will be repeated for each year's new cohort of participants. In addition, by using the natural environs of the southern coastal region as well as the New Jersey Pine Barrens as backdrops, the Cumberland Collaborative will strive to create interdisciplinary activities in math and science each year that will raise awareness, appreciation and stewardship of the environment of our region, our state and our planet.
