SUBJECT: Fiscal Year 2012 R&PD Internal Grants Recommendations

The Call for Proposals for FY12 Research and Professional Development awards received applications from 47 faculty members who requested a total of \$242,178—35% more than is available. They requested an average award size of \$5,120; 26% of the applicants are tenured. Among the 47 proposals received, 19 (40%) indicated their projects supported the College's Strategic Initiatives. The Committee members noted that the proposals were stronger this year than in years past, thereby increasing competition for a limited pot.

Please find below the recommendations of the R&PD Committee to fund 36 projects with FY 12 awards, which represents support for 77% of the applications received. Each proposal was reviewed by each individual committee member and then fully discussed by the collective. In order to support 36 projects recommended here, the Committee cut or did not support for funding a total of \$62,178 or 26% of the total amount requested. Fourteen (39%) of those recommended will support College Initiatives. The Committee recommendations will keep the total amount of awards at the budget of \$180,000.


Recognizing that College budgets are spread thin and must compete with many needs, the Committee is especially pleased that faculty support structures remain sound and robust. Thanks so much.

Browser Check for Success

Web-based resources rely on a properly configured browser. To make this easier for the campus community, an integrated browser check, including checks for our various online resources is available on the goStockton Portal login page and inside the portal in the My Courses channel. The browser check automatically detects the browser being used and provides browser-specific instructions for fixing problems. An instructional video is also available.

Stockton QuickMail

One of the most frustrating experiences on the web is to click on an email address in a web page and get an error message. Webmasters expect that their visitors will have an email program configured. This is often not the case. Stockton QuickMail provides a solution for Windows-based computers. After installation, when the end user clicks on an email address in a web page, s/he will authenticate to the Stockton system and a message window will open, and user types in a message and clicks send. A copy of the message is automatically sent to the user's Stockton email address.

Preceptorial Advising & Web Appointment Scheduling

To facilitate communication between preceptors and their preceptees, course sections have been created in the Blackboard learning management system. Using these sections, advisors can post articles of interest, post links to web pages of interest, answer student questions via discussion boards, host online chat sessions, and hold online office hours. Additionally, a new software module has been incorporated into Blackboard allowing preceptors to provide virtual sign-up sheets for appointments. Students no longer need to come to campus and visit the preceptor's office to sign a physical piece of paper. Students receive an email confirmation of the appointment and receive an email reminder the before the appointment. On campus, this system will also provide the preceptor with a picture of the person who made the appointment.

More Green Initiatives

In an effort to further remove paper from campus processes, Computer & Telecommunication Services has been working with various departments to create new electronic processes. For Human Resources, a workflow was created to handle managerial evaluations. For Admissions, an online application review summary process was developed. For Continuing and Professional Education, the Flexible Registration module has been incorporated into Banner. For Financial Aid, the student bill has been updated to reflect pending aid. For the Bursar and Financial Aid, a new tab titled "Payments & Financial Aid" has been created in the goStockton Portal for students.

Going Wireless

Wireless access to the Stockton network is now available in all campus residential facilities.

Supporting Campus Safety

Computer and Telecommunications Services, in conjunction with the Campus Police Department, completed the installation of approximately 150 security cameras throughout the entire campus. FACILITIES PLANNING AND CONSTRUCTION

Campus Center

The General Contractor has obtained a Temporary Certificate of Occupancy as of April 4, 2011. The Contractor is in the process of final cleaning of all office spaces, and Stockton staff relocations into the building have begun.

Backfill/Decanted Renovations

Upper N-Wing – This project includes a complete renovation of pre-existing office space in order to accommodate the financial arm of Administration & Finance. The design has been completed and bids for construction were received March 23, 2011. The construction Notice to Proceed has been issued.

G-Wing – This project consists of the renovation of the pre-existing kitchen/cafeteria (1st floor) and the former Campus Center (2nd floor) in order to provide faculty offices and academic space for the School of Behavioral Sciences (SOBL) and the School of Business. The design has been completed and bids for construction were received March 30, 2011. The construction Notice to Proceed has been issued.

Plant Management Renovations – This project consists of an addition and renovation to the existing Plant Management Building in order to accommodate Plant Management, Purchasing and the Facility Planning & Construction departments. The design is complete and bids for construction were received March 17, 2011. The construction Notice to Proceed is pending.

Parkway Building Renovation (SASI Project)

This project consists of an adaptive re-use of the current Administration and Finance offices to become a facility to accommodate the Southern Regional Institute (SRI/ETTC) and the Speech and Hearing Clinic from the School of Health Sciences. The Renovation design has been accepted by

the College. The guaranteed maximum price has been established with the Contractor and construction will begin in September 2011.

Unified Science Center

To support the College's Sciences and Mathematics Programs, a three-story, 66,350 gross square foot building will be constructed. This building will include wet and dry laboratories, classrooms and support facilities. Construction bids were received March 31, 2011. Contract award and Notice to Proceed has been provided. Construction will begin May 2011.

Solar Grant – American Reinvestment and Recovery Act

This project consists of the design and construction of solar energy panels mounted on canopies above the parking lots on the North side of campus. It also includes certain energy savings improvements to our residential housing units. A contract was awarded to a developer who will design, construct and own the project in order to sell electricity to Stockton at a below-market rate. Construction will commence on or about May 15th. This project is scheduled for completion during late summer 2011.

Independence Walk Reconstruction

Phase I – This project consists of the installation of brick pavers and plantings from K-wing Plaza to F-wing Plaza, incorporating H-wing Plaza, which is directly behind the main entrance to the Campus Center. All concrete sidewalks have been replaced having introduced more durable and aesthetically pleasing materials. This project is complete.

Phase II – This project consists of the renovation of the balance of Independence Walk that was not completed in Phase I and includes the remaining courtyards. Construction bids for this work have been received and the Notice to Proceed is pending.

L-Wing Renovation

This project is an adaptive reuse of the former swimming pool facility and will provide a two-story art gallery, four classrooms and lecture halls, as well as administrative offices. The steel erection is complete and the interior framing is currently taking place. It is expected that the project will be complete for fall occupancy.

C/D-Wing Courtyard Renovation

This project is the construction of an Atrium addition between C and D wings. The steel framing is complete and the building skin construction is in process. This project will be complete for fall use.

Performing Arts Center Renovation (PAC)

This project consists of construction of a new box office, expansion of lobby space, a new entrance to the PAC lobby and construction of an addition that will increase toilet facility capacity. This project will be complete for fall use.

Electrical Feeder Upgrade

This project consists of the design and installation of additional electrical capacity that will enable the operation of the new Unified Science Center. The project is designed and is being reviewed for permitting, anticipating a summer 2011 construction bid.

Hammonton Adaptive Reuse (SASI Project)

This project consists of the renovation of a three-story, 15,000 square foot former factory in downtown Hammonton, New Jersey. It will provide academic, retail and art gallery spaces for use

by Stockton and the local community. A designer has been selected and construction completion is forecasted for fall 2012.

OFFICE OF PLANT MANAGEMENT AND HOUSING MAINTENANCE

The Department of Plant Management and Housing Maintenance continues to support daily maintenance operations, supports numerous events including student, athletic and community based programs, initiates and manages campus-wide renewal and renovation projects and schedules and maintains regulatory compliance for the College.
