### **Mobilizing Stockton Student Email**

Our employees have long had the capability of accessing their Stockton email on mobile devices. Beginning October 6, 2011, student email on the goStockton Portal became available for student access on mobile devices. This is just the first step in a larger ongoing project to add mobile access to key portions of our online resources for our internal constituents, i.e. employees and students.

### **Electronic Capabilities at Seaview**

Our campus has rich presentation resources in its classrooms and meeting spaces. These capabilities have now been expanded to the divisible classroom space at the Seaview Hotel. A new audio/visual system has been installed, enabling flexible technology resource usage. A customized interface, programmed by Brian Cole of Computer & Telecommunication Services, allows this space to be divided into three separate zones or any combination of zones.

### **Tech Rewards**

A new feature has been added to our technology training program. This experimental program, called "Tech Rewards," is designed to provide additional, technology-related professional development opportunities for Stockton employees. Each month, attendees at our training seminars will be entered into a random drawing. Employees can be entered into the drawing multiple times – once for each seminar they attend. The winner of the drawing will receive 90 minutes of individual training on any of the topics covered in our technology training curriculum. For each Technology Boot Camp, there will be 3 winners. These one-on-one sessions will be scheduled at mutually convenient times. Winners will be announced each month in the portal.

### **Working Smarter**

A variety of manual processes have been streamlined with automation, enabling College offices to work smarter, not harder. An interface has been written to accept student applications for admission through the Common Application website, eliminating the need to print out applications and manually enter date. Progress toward graduation is now tracked automatically and students are automatically notified when their graduation application has been forwarded to the preceptor for review. A workflow has been developed to automatically notify appropriate offices when an employee has been terminated.

In conjunction with the Dean of Students' Office, Student Development, Stockton Neighborhood Watch, the HERO Club and Greek Life, Team Stockton had nearly 40 walkers supporting the HERO Campaign in their first fund raising walk in Ocean City in October.

The Police Department hosted the NJ College and University Public Safety Association's monthly meeting at Seaview Resort in November. Over 40 attendees from over 20 colleges were present and enjoyed the hospitality. Alice Guy from AtlantiCare presented to the group on Bullying.

The Police Department wishes to welcome a new Security Officers to our staff. **JASON ANDREWS**, an Alternate Route Police Academy graduate is now in the police officer training program.

Officers **TRACY STUART** and **BRIAN WIDELL** with assistance from Christy Cunningham from the Career Center conducted a Rape Aggression Defense (RAD) training seminar for 10 women students in October and November.

## **FACILITIES PLANNING AND CONSTRUCTION**

### **Backfill/Decanted Renovations**

Upper N-Wing – This project includes a complete renovation of pre-existing office space in order to accommodate the financial arm of Administration & Finance. This project has been completed in its entirety and the space is fully occupied by the financial arm of Administration & Finance.

G-Wing – This project consists of the renovation of the pre-existing kitchen/cafeteria (1<sup>st</sup> floor) and the former Campus Center (2<sup>nd</sup> floor) in order to provide faculty offices and academic space for the School of Behavioral Sciences (SOBL) and the School of Business. This project has been completed in its entirety and the space is fully occupied by the School of Business and the School of Behavioral Sciences.

Plant Management Renovations – This project consists of an addition and renovation to the existing Plant Management Building in order to accommodate Plant Management, Purchasing and the Facility Planning & Construction departments. This project has been completed in its entirety and the space is fully occupied by The Facilities & Plant Operations organization as well as the Purchasing organization.

J-Wing – This project consists of the renovation of Upper & Lower J-wing in order to accommodate the delivery of Administrative & Academic space for the School of Education and The School of General Studies. It will also include the expansion of the Human Resources Department. The space is being designed in preparation for construction bid in the 1<sup>st</sup> Quarter of 2012.

### **Parkway Building Renovation (SASI Project)**

This project consists of an adaptive re-use of the current Administration and Finance offices to become a facility to accommodate the Southern Regional Institute (SRI/ETTC) and the Speech and Hearing Clinic from the School of Health Sciences. This project is substantially complete and in the process of being occupied by the Southern Regional Institute (SRI/ETTC) and the Speech and Hearing Clinic from the School of Health Sciences. Academic operations will take place in time for the start of the fall semester.

### **Unified Science Center**

To support the College's Sciences and Mathematics Programs, a three-story, 66,350 gross square foot building will be constructed. This building will include wet and dry laboratories, classrooms and support facilities. Construction bids were received March 31, 2011. Contract award and Notice to Proceed has been provided. Construction is well underway and in the process of installing footings and foundations. Our expectation is that the 1<sup>st</sup> Quarter of 2012 will consist primarily of construction of the building frame, with an expectation for the project to be complete in the 2nd Quarter of 2013.

### **Solar Grant – American Reinvestment and Recovery Act**

This project consists of the design and construction of solar energy panels mounted on canopies above the parking lots on the North side of campus. It also includes certain energy savings improvements to our residential housing units. A contract was awarded to a developer who will design, construct and own the project in order to sell electricity to Stockton at a below-market rate. The energy saving improvements for this project has been completed and are in use. The construction of the solar car canopies is underway in the north lot. Construction was commenced during the month of August 2011 and is scheduled for completion 1<sup>st</sup> Quarter of 2012.

### **Independence Walk Reconstruction Phase II**

This project consists of the renovation of the balance of Independence Walk that was not completed in Phase I and includes the remaining courtyards. Construction bid documents have been assembled, approved for permitting by the DCA and awaiting budget approval prior to bid.

### **L-Wing Renovation**

This project is an adaptive reuse of the former swimming pool facility and will provide a two-story art gallery, four classrooms and lecture halls, as well as administrative offices. The interior has progressed such that finishes (drywall & painting is underway). This project is substantially complete and being occupied by the respective end users.

### **C/D Atrium Addition & Courtyard Renovation**

This project is the construction of an Atrium addition between C and D wings. The steel framing is complete and the building skin construction is in process. This project is substantially complete and in use.

### **Performing Arts Center Renovation (PAC)**

This project consists of construction of a new box office, expansion of lobby space, a new entrance to the PAC lobby and construction of an addition that will increase toilet facility capacity. Construction is underway and this project is complete and in use.

### **Electrical Feeder Upgrade**

This project has been bid and an award has been issued. Construction is to begin fall 2011. This project consists of the design and installation of additional electrical capacity that will enable the operation of the new Unified Science Center. This project has been awarded and is under construction. We expect completion spring 2012.

### **Hammonton Adaptive Reuse (SASI Project)**

This project consists of the renovation of a three-story, 15,000 square foot former factory in downtown Hammonton, New Jersey. It will provide academic, retail and art gallery spaces for use by Stockton and the local community. Bids were received in the month of August. A contractor has been selected. The Town of Hammonton is in the process of making an award and entering into a contract. Construction completion is forecast for winter 2012, on time for use spring semester 2013.

### **Manahawkin Academic Space**

Stockton is collaborating with AtlantiCare for the joint development of healthcare and academic space in the shore town of Manahawkin, with Stockton considering 6,000 to 10,000 square feet of academic space for our programming needs. This project is currently in the early stages of design anticipating negotiations with the prospective landlord for the space.

### **Azeez Museum**

The College is now in possession of the Azeez Facility and is presently collaborating with the donor towards an academic addition for this space. Pre-design efforts are underway in this regard.

## **HUMAN RESOURCES**

**KATHY FRANZESE** and **KAREN TIERNEY** attended the CUPA-HR (College & University Professional Association for Human Resources) annual conference and exposition on September 25-27. The focus of this year's conference revolved around the themes of diversity and inclusion. **Karen** points out key learnings for her concerned the application of the conference theme in the areas of mediation practices and the metrics of organizational engagement. **Kathy** was able to attend sessions on On-Boarding redesign and wellness programs, both of which have applications that can be included in OHR's on-going programs.

At the request of the Office of General Counsel, OHR developed an Identity Theft "Red Flag" training program to be presented to all College impacted Departments and Offices. Completion of this training will meet compliance requirements of Federal legislation.

In conjunction with the Office of Institutional Planning and Research, OHR developed an on line tutorial entitled *Coaching for Ideas*. The tutorial is designed to assist 2020 Initiative team members in coaching College community "idea generators" through the "idea process" from conception to fruition.

## **OFFICE OF PLANT MANAGEMENT AND HOUSING MAINTENANCE**

The Department of Plant Management and Housing Maintenance continues to support daily maintenance operations, supports numerous events including student, athletic and community based programs, initiates and manages campus-wide renewal and renovation projects and schedules and maintains regulatory compliance for the College.

## **ACKNOWLEDGEMENT**

In acknowledgment of the College's enrollment in the "PowerPay!" energy curtailment program and its subsequent decrease of energy usage, Green Roots Environmental Initiative has presented ten (10) native pine, fir and cedar trees to be planted by the Arbor Day Foundation in the Shasta Trinity National Forest, California. These trees are to commemorate the Richard Stockton College of New Jersey's commitment to the community and its efforts to go green.

- Clock Installation  
Plant Management supported the installation of a 4-sided Stockton replica street clock, located at the intersection of the West Quad and the new Campus Center.
- N-Wing Chiller and Hot Water Heater System Replacement  
As part of Plant Management's deferred maintenance initiative, the N-Wing chiller and hot water heater units have reached the end of their useful life and have been replaced with new, high efficiency systems.
- Programmable Wireless Lock Installation  
Plant Management installed wireless communication locking devices on the Campus Center Theater and Meeting Rooms One (1) through Five (5) to allow the inclusion of these areas in the Campus Lockdown Procedure.

## **HOUSING MAINTENANCE & IN-HOUSE PROJECTS**

- Housing III O-Dorm ADA Accessibility  
ADA accessible hardware was installed on the exterior building and the first floor suite door of Housing III O-Dorm in order to provide increased special needs accessibility.

## **GREEN INITIATIVES**

- Housing I Thermostat Installation  
The installation of remotely accessible thermostats throughout the Housing I Complex was completed as part of American Recovery and Reinvestment Act (ARRA) grant funding. Plant Management will be provided with the ability to control and monitor the temperature remotely, which will greatly decrease energy usage during peak energy periods. The new units will permit a better standardization of climate control throughout the apartments, along with an ease in correcting temperature control issues. All thermostats have been installed and are in use.
- Lakeside Lodge Lighting Upgrade  
The thirty-six (36) recessed lights in the Lakeside Lodge multi-purpose room, previously housing 150 watt incandescent bulbs, were replaced with 17 watt LED bulbs.

The **Office of Development and Alumni Affairs** and **The Stockton College Foundation** held the Annual Stockton College Golf Classic on October 6<sup>th</sup> at Seaview. The Classic Co-Chairs, Janice Bond of Galaxy Technology and Betty Lorenzetti provided leadership for the volunteer committee comprised of 30 local community members. **During the month of October two major gift commitments were closed.**

- **The O'Brien College Education Dream Come True Fund** will establish an endowment fund of \$100,000 over the next five years, and will include an annual use gift of \$4,000 for needs-based student support, and an annual fund gift of \$1,000 per year.
- **The Dr. Janice Joseph Tuition Award** was established as an annual gift of \$1,000 for the benefit of undergraduate students pursuing a degree from the School of Social and Behavioral Sciences.

- Written confirmations of actual occupancy numbers for campus housing are due 30 days in advance of arrival

**B. Cancellations:** In the event of cancellations, nonrefundable deposits accrue as follows:

- The administrative fee is remitted to the office that developed and executed the contract.
- The remaining deposit monies would be remitted to the appropriate account in proportion to the facilities fees outlined on the contract.

## **XVII. NOTES AND SPECIAL CONDITIONS**

### **A. Personnel and equipment use costs associated with specific events**

The College reserves the right to assess special charges to cover additional College expenses.

### **B. State-mandated liability insurance fees**

Groups are required to have \$1,000,000 individual and \$3,000,000 aggregate bodily injury and liability policy issued by a Class A company, assignable to the College. (Note: This rate schedule is established by the NJ Office of Risk Management and is subject to change.)

### **C. Co-sponsorship criteria**

Events involving recognized College clubs and/or organizations, offices, departments and/or divisions partnering or collaborating with external groups for events using College facilities, equipment and/or services will be considered College co-sponsored activities or events. Co-sponsored events must meet all of the following requirements:

1. Prior approval of the appropriate budget unit head, dean, and/or vice president;
2. Adhere to the appropriate provisions of College facility usage fees and College procedures and policies;
3. Share and/or absorb appropriate costs associated with the event not born by the external group;
4. Provide the appropriate personnel to plan and/or manage the event as determined by the Office of Event Services and Campus Center Operations.

### **D. Fundraising surcharge for groups utilizing Stockton facilities to raise revenue**

Ordinarily, no outside group may use state facilities for fundraising purposes when the beneficiary is other than the College, unless specifically authorized in writing by the Vice President for Administration. In this event, fees may be applied at the discretion of the Vice President for Administration and Finance.

### **E. Dining Contracts**

Dining contracts and billing arrangements are handled by the College's contracted food service provider.

### **F. Amounts overdue**

Amounts 90 days past due by outside groups will be charged interest at the rate of 10%.

### **G. Waivers**

1. Facility, equipment, labor, utility or service fees may be discounted or waived by the President or the Vice President for Administration and Finance under special circumstances for College organizations, governmental agencies or non-profit organizations for events that are consistent with the mission of Stockton College.
2. In cases where facility, equipment, labor, utility or service fees are waived or discounted, the College is authorized to charge a non-refundable administrative fee.
