FACILITIES PLANNING AND CONSTRUCTION

Backfill/Decanted Renovations

J-Wing – This project consists of the renovation of Upper & Lower J-wing in order to accommodate the delivery of Administrative & Academic space for the School of Education and The School of General Studies. It will also include the expansion of the Human Resources Department. The space is being designed in preparation for construction bid in the 1st Quarter of 2012.

Unified Science Center

To support the College's Sciences and Mathematics Programs, a three-story, 66,350 gross square foot building will be constructed. This building will include wet and dry laboratories, classrooms and support facilities. Construction bids were received March 31, 2011. Contract award and Notice to Proceed has been provided. The building structural steel framing is nearing its completion, and concrete masonry work will commence shortly thereafter. Our expectation is that the 1st Quarter of

2012 will consist primarily of construction of the building frame, with an expectation for the project to be complete in the 2nd Quarter of 2013.

Solar Grant – American Reinvestment and Recovery Act

This project consists of the design and construction of solar energy panels mounted on canopies above the parking lots on the North side of campus. It also includes certain energy savings improvements to our residential housing units. A contract was awarded to a developer who will design, construct and own the project in order to sell electricity to Stockton at a below-market rate. The energy saving improvements for this project has been completed and are in use. The construction of the solar car canopies is underway in the north lot. Construction was commenced during the month of August 2011 and is scheduled for completion 1st Quarter of 2012.

Independence Walk Reconstruction Phase II

This project consists of the renovation of the balance of Independence Walk that was not completed in Phase I and includes the remaining courtyards. Construction bid documents have been assembled and approved for permitting by the DCA and awaiting budget approval prior to bid.

Electrical Feeder Upgrade

This project has been bid and an award has been issued. Construction is to begin fall 2011. This project consists of the design and installation of additional electrical capacity that will enable the operation of the new Unified Science Center. This project has been awarded and is under construction. We expect completion spring 2012.

Hammonton Adaptive Reuse (SASI Project)

This project consists of the renovation of a three-story, 15,000 square foot former factory in downtown Hammonton, New Jersey. It will provide academic, retail and art gallery spaces for use by Stockton and the local community. Construction is underway having performed environmental remediation as well as selective demolition. Construction completion is forecast for winter 2012, on time for use spring semester 2013.

Manahawkin Academic Space

Stockton is collaborating with AtlantiCare for the joint development of healthcare and academic space in the shore town of Manahawkin, with Stockton considering 6,000 to 10,000 square feet of academic space for our programming needs. This project is currently in the early stages of design anticipating negotiations with the prospective landlord for the space.

Azeez Museum

The College is now operating the Azeez Facility and is presently collaborating with the donor towards an academic addition for this space. Design efforts are underway to develop a two-classroom facility.

Parking Lot & Outdoor Tennis Stadium Development

A feasibility study is underway to assess the possibility of advancing the further development of the Pomona Road Athletic Complex to include 8 tennis courts, observation stands and parking. With this effort, we are also considering the enhancement of core campus parking accommodations by renovation of existing tennis courts to become gated and secure parking lots.

Center for Sustainability

A design study is being undertaken to explore the development of a 6,000 sq. ft. academic facility for use by the newly created academic Sustainability Program. This facility will include lecture halls as well as lab space and be constructed with energy efficiency and sustainability in mind.

HUMAN RESOURCES

In an effort to reduce workplace injuries and the cost associated with worker's compensation, Human Resources, in conjunction with Department of Occupational Therapy, have completed Workplace Safety Training for all of Plant maintenance. OT graduate students shadowed the different trades, grounds and custodial staff and based on their observations they were able to show proper techniques and make safety recommendations.

The Office of Human Resources completed Informational Sessions regarding changes in legislation regarding 2012 NJ State Health Benefits Program.

In accordance with the College's Identity Theft Prevention Program Policy, Human Resources, at the request of the Office of General Counsel conducted training designed to familiarize the College with the objective and requirements of the program. The targeted departments were those areas that have access to confidential information such as Human Resources, Bursar, Registrar and Computer Services.

In an effort to further remove paper from campus processes, Human Resources, has embarked on the Xtendor project. The department has completed 25 % of all Stockton personnel files.

OFFICE OF PLANT MANAGEMENT AND HOUSING MAINTENANCE

The Department of Plant Management and Housing Maintenance continues to support daily maintenance operations, supports numerous events including student, athletic and community based programs, initiates and manages campus-wide renewal and renovation projects and schedules and maintains regulatory compliance for the College.

CAMPUS MAINTENANCE & IN-HOUSE PROJECTS

- **Campus Renovations & Office Moves**

Various renovation and office moves have occurred throughout the Campus: the newly renovated L-Wing space is now occupied by the William J. Hughes Center, the Office of External Affairs, the Office of Affirmative Action and the Institutional Research Office, along with six (6) faculty offices; the F218 Suite, previously the Grants Office, is now the home of the Creative Writing Lab; the E-Wing Gallery was renovated to allow natural light and additional seating for congregating.

- **Lower L-Wing Athletic Area**

The lower L-Wing area, which was previously designated as mechanical equipment space for the eliminated pool, will be redeveloped and utilized as an expanded weight room and exercise facility. Modifications for the area include adapted entrances to the existing locker rooms.

HOUSING MAINTENANCE & IN-HOUSE PROJECTS

- **Housing V Windows and Roofs**

The bay window area in each of the five (5) buildings in Housing V has been reroofed in order to provide uncompromised building envelope.

GREEN INITIATIVES

- **Water Bottle Filling Stations**

Three (3) water bottle filling stations have been installed in J-Wing, K-Wing and the Facilities & Plant Operations building for use by faculty, staff and students, in an effort to encourage the use of refillable water bottles. This will reduce the amount of recycled waste the College produces and reduce our carbon footprint.

- **Frozen Precipitation Pre-Treat System**

In anticipation of inclement winter weather, Plant Management's Grounds Department has procured a large sprayer unit and an individual walk behind sprayer. Both units will distribute potassium acetate, a ready-to-use pre-treatment for the de-icing of roads and walkways. This compound is non-damaging to most surfaces, including concrete, metal and wood, while remaining non-toxic and non-hazardous to Campus plant and animal life.
