## **COMPUTERS AND TELECOMMUNICATION**

### **One Username, One Password**

Single sign-on is now a part of the Stockton computer labs. Students are now able to log in to computers in our labs with their goStockton portal username and password. This has significant advantages for the students. They will be able to store and retrieve personal files (up to 250 MB). They will also have the ability to set up an individual user profile with computer settings unique to the individual. This is especially important for students in our Learning Access program who may need special accessibility settings or software.

### **Virtually Yours**

Server virtualization allows us to break a large physical server into smaller virtual servers, saving money on hardware and electricity. Computer & Telecommunication Services continues to migrate physical servers to virtual servers. The college web and database servers were transitioned to our virtualized server farm, at the request of the Faculty Senate a web server was created and configured to support the D-Space Document Repository project, and at the request of Plant Management and Facilities Planning, a server was created for documents.

### **Green and Greener**

In further support of Stockton's ongoing process of greening the College, a new tool was developed by Computer & Telecommunication Services for the intake of student applications for admission. In the past, student applications were paper-based, requiring storage space and incurring duplication costs (to allow multiple individuals to review the documents). The online application data feeds student information directly into the Banner student information system. Reviewers may easily retrieve an application. Queries may be done on the application pool as a whole, based on a variety of application fields (e.g., SAT scores, geographic information). Acceptance decisions can now be made without the delays caused by duplication and distribution of paper copies.

### **Data Center Power Upgrade**

An uninterruptible power supply (UPS) and power distribution unit were initially installed in the Stockton data center in 1989. The original equipment served us well, but was in need of an upgrade and replacement to meet the needs of the current campus technology infrastructure. On May 13, 2011, final work was completed on the replacement and upgrade of the data center UPS and power distribution system.

### **Touching the Community**

Technology staff and resources are not just here for the campus community. Our resources touch the community, as well. Computer & Telecommunication Services facilitated the web stream and overflow projection of the Commencement ceremonies on Saturday May 9, 2011. Additionally, more than 400 people watched the live stream of the ceremonies over the web. The new Campus Center has been configured with audio visual equipment providing visitors with instant information on the location of resources and activities. (Special recognition goes to Demetrios Roubos for his extraordinary efforts in conjunction with our audio/visual vendor to complete this project for the ribbon cutting ceremony.) On May 12, 2011 Bob Heinrich presented the keynote address at the 3<sup>rd</sup> annual New Jersey Education Technology Institute Conference.

### **Supporting Assessment Efforts**

Ongoing assessment is vital to institutional improvement. Computer & Telecommunication Services supports assessment efforts by developing associated technology tools. Using the Banner Workflow product, which allows for the tracking of tasks and documentation, a workflow process was set up for the managerial review process. Custom applications were built for both the academic deans' evaluation and student evaluation of instruction for course sections with smaller enrollments.

## **FACILITIES PLANNING AND CONSTRUCTION**

### **Campus Center**

The General Contractor has obtained a Temporary Certificate of Occupancy as of April 4, 2011. The Contractor is in the process of final cleaning of all office spaces, and Stockton staff relocations into the building have begun.

### **Backfill/Decanted Renovations**

Upper N-Wing – This project includes a complete renovation of pre-existing office space in order to accommodate the financial arm of Administration & Finance. The construction Notice to Proceed has been issued and construction is underway, to be completed by August 2011.

G-Wing – This project consists of the renovation of the pre-existing kitchen/cafeteria (1<sup>st</sup> floor) and the former Campus Center (2<sup>nd</sup> floor) in order to provide faculty offices and academic space for the School of Behavioral Sciences (SOBL) and the School of Business. The construction Notice to Proceed has been issued and construction is underway, to be completed by August 2011.

Plant Management Renovations – This project consists of an addition and renovation to the existing Plant Management Building in order to accommodate Plant Management, Purchasing and the Facility Planning & Construction departments. The construction Notice to Proceed has been issued and construction is underway, to be completed by August 2011.

### **Parkway Building Renovation (SASI Project)**

This project consists of an adaptive re-use of the current Administration and Finance offices to become a facility to accommodate the Southern Regional Institute (SRI/ETTC) and the Speech and Hearing Clinic from the School of Health Sciences. The Renovation design has been accepted by the College. The guaranteed maximum price has been established with the Contractor and construction will begin in September 2011.

### **Unified Science Center**

To support the College's Sciences and Mathematics Programs, a three-story, 66,350 gross square foot building will be constructed. This building will include wet and dry laboratories, classrooms and support facilities. Construction bids were received March 31, 2011. Contract award and Notice to Proceed has been provided. Construction has begun with an expectation to be complete in the 1<sup>st</sup> Quarter of 2013.

### **Solar Grant – American Reinvestment and Recovery Act**

This project consists of the design and construction of solar energy panels mounted on canopies above the parking lots on the North side of campus. It also includes certain energy savings improvements to our residential housing units. A contract was awarded to a developer who will design, construct and own the project in order to sell electricity to Stockton at a below-market rate. Construction will commence during the month of June and is scheduled for completion during early fall 2011.

## **Independence Walk Reconstruction**

**Phase I** – This project consists of the installation of brick pavers and plantings from K-wing Plaza to F-wing Plaza, incorporating H-wing Plaza, which is directly behind the main entrance to the Campus Center. All concrete sidewalks have been replaced having introduced more durable and aesthetically pleasing materials. This project is complete.

**Phase II** – This project consists of the renovation of the balance of Independence Walk that was not completed in Phase I and includes the remaining courtyards. Construction bid documents have been assembled awaiting budget approval prior to bid.

## **L-Wing Renovation**

This project is an adaptive reuse of the former swimming pool facility and will provide a two-story art gallery, four classrooms and lecture halls, as well as administrative offices. The steel erection is complete and the interior framing is currently taking place. It is expected that the project will be complete for fall occupancy.

## **C/D-Wing Courtyard Renovation**

This project is the construction of an Atrium addition between C and D wings. The steel framing is complete and the building skin construction is in process. This project will be complete for fall use.

## **Performing Arts Center Renovation (PAC)**

This project consists of construction of a new box office, expansion of lobby space, a new entrance to the PAC lobby and construction of an addition that will increase toilet facility capacity. Construction is underway and this project will be complete for fall use.

## **Electrical Feeder Upgrade**

This project consists of the design and installation of additional electrical capacity that will enable the operation of the new Unified Science Center. The project is designed and is being reviewed for permitting, anticipating a summer 2011 construction bid.

## **Hammonton Adaptive Reuse (SASI Project)**

This project consists of the renovation of a three-story, 15,000 square foot former factory in downtown Hammonton, New Jersey. It will provide academic, retail and art gallery spaces for use by Stockton and the local community. A designer has been selected and construction completion is forecasted for fall 2012. Design documents are 50% complete.

Plant Management completed the Campus Center move-in on schedule. This consisted of the relocation of ten (10) departments from various areas throughout the Main Campus to the new Campus Center.
- **Potable Water Storage Tank Repairs**  
Maintenance and repairs were completed to the Campus' 300,000-gallon potable water storage tank. These improvements were deemed necessary by the College's recent potable water study.

### **Housing Maintenance & In-House Projects**

- **Housing I Furniture Replacement**  
The desks and chairs in A and C-Courts were replaced. This completes Plant Management's four (4) year renewal initiative to replace all desks in Housing I.
- **Building 88 Geothermal HVAC System Replacement Upgrade**  
This pilot initiative allows Plant HVAC staff to remotely control and monitor the temperature throughout the individual apartments of Housing IV Building 88. It has greatly improved climate control and will provide increased resident satisfaction.
- **Housing I Gas Meters**  
All of the Housing I gas meters were replaced as part of an ongoing initiative by South Jersey Gas to improve gas delivery to the College.

### **Green Initiatives**

- **Water Bottle Filling Stations**  
Three (3) water bottle filling stations were installed in the F-Wing Gallery, West Quad and the Sports Center for use by faculty, staff and students, in an effort to encourage the use of refillable water bottles. This will reduce the amount of recycled waste the College produces and reduce our carbon footprint.
- **Building 88 Geothermal HVAC System Replacement Upgrade**  
This pilot initiative in Housing I Building 88 allows Plant HVAC staff to remotely control and monitor the temperature throughout the individual apartments. This will allow network infrastructure improvements and will generate significant energy savings.

A major achievement in 2010 was his work to obtain a \$50,000 grant from the Office of Homeland Security to implement the police department's first K-9 Unit, a major milestone in the department's history. This work and much more has defined the Police Department's values of Integrity, Dedication, Excellence, Achievement and Loyalty.

We, the members of the Career Development Committee, reviewed the applicant files and met on Wednesday June 8, 2011 to discuss them and reach our recommendations. We recognize that the final decision is based on the President's approval.

In our process we were cognizant that the total funds requested were \$63,101.92, while the funds available are \$21,000.00. We carefully considered the quality of each proposal, including clarity of activities, benefits, budget breakdown and justification. The Assessment Committee's letter for each candidate and the criterion of career development of the applicant were included in our judgments. Given that there was insufficient money to fund all worthy projects, the availability and appropriateness of other sources of institutional support was also weighed.
