Unified Science Center

To support the College's Sciences and Mathematics Programs, a three-story, 66,350 square foot building has been constructed. The building has been occupied since the beginning of the fall semester. It is anticipated that a final Certificate of Occupancy (CO) will be obtained in December 2013.

Lakeside Lane Parking Lot

The parking addition will be constructed over the existing tennis courts behind L-Wing. The Pinelands Commission approved the project in August. Construction has begun and is anticipated to be complete in December 2013.

B & F Wing Roof Replacement

This project consists of the complete removal and replacement of the roofing membrane and insulation materials associated with the B & F Wings. Finishing work has been interrupted due to odors permeating the building from the roofing mastic. The project is being completed on weekends to minimize inconveniences to students, faculty and staff. It is anticipated that the work will be complete by the middle of November.

ADA Survey

The College has contracted with SOSH Architects to conduct an ADA (Americans with Disabilities Act) Survey of the campus to identify access issues and recommend design solutions to allow faculty, students, staff and visitors improved access to campus facilities. The study is complete and will undergo an in-house review.

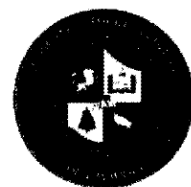
