The fund for the **Constantelos Hellenic Collection and Reading Room** is currently at \$187,260. This includes two generous gifts; \$50,000 from Dean and Zoe Pappas and \$100,000 from the Friends of Hellenic Studies to be used as matching challenge gifts .

Fundraising for the **Hammonton Scholarship Endowment** has begun. \$10,000 has been pledged, representing 10% of the initial \$100,000 goal.

Since January, the **Annual Giving Program** has completed several initiatives. The second bi-annual presidential appeal letter was sent to all historical alumni donors. Appeal letters were also sent to the following alumni segments: Social Work, Environmental Science/Studies, Communications Studies. A 'Housing Challenge' project began in March, encouraging alumni and current students to donate in honor of their favorite Court (A-H) for which they have a strong affinity. As of early April, these initiatives resulted in more than \$10,000 in gifts.

As of April 8, 2 weeks into the 6 week spring program, **phone-a-thon** has secured nearly \$15,500 in gifts and pledges.

**Social media** metrics continue to increase. Facebook 'likes' have increased by 63% since May 2013 (1,873 to 2,779); Twitter 'followers' have increased 100% since May 2013 (284 to 539). Members of our LinkedIn network have increased 27% from May 2013 (1,980 to 2,711).

**A new scholarship endowment**, the Clair Levine '78 Scholarship, was established to provide an annual award to a qualified student.

Sinclair and Warren qualified for their honors by compiling grade point averages above 3.30 and finishing among the top 25 percent at the NCAA Regionals. In the classroom, Sinclair is a speech pathology major with a perfect 4.0 grade point average, one of 12 out of the 308 honorees to post a spotless GPA. Warren boasts a 3.72 grade point average as a physical therapy major.
