#### Dear Provost Kesselman:

The R&PD committee met on October 24, 2014 to evaluate applications for sabbatical for Fall 2015 and Spring 2016. We received proposals from 12 faculty members, requesting a total of 15 semesters. After discussion and deliberation, the committee recommends 11 semesters for the 9 projects it found meritorious, as listed below. These reflect four of the academic Schools and the Library.

Koh, Adeline. ARHU. "Postcolonial Digital Humanities and Digitizing Chinese Englishmen. Fall 2015 and Spring 2016.

I plan to 1) write one chapter, the introduction, conclusion, appendix and revise a chapter of a coauthored book (*Postcolonial Digital Humanities*), and 2) complete work on a proof-of-concept for Digitizing Chinese Englishmen (digital humanities project).

The book lays out the genealogy of a new field that draws upon the intellectual heritage and disciplinary structure of both digital humanities and postcolonial studies and articulates a base for postcolonial activist praxis.

Lague, Michael. NAMS. "Evolution of the Human Arm." Fall 2015 and Spring 2016.

My research will involve analysis of the humerus (arm bone) of apes and humans to test three hypotheses regarding species identification and upper limb function in our early ancestors: 1) To assess the extent to which fossil species can be recognized based on humeral anatomy, 2) To test hypotheses regarding upper limb use in fossil hominins, and 3) To establish a comparative context for interpreting a new fossil upper limb.

Li, Wei-Xuan. BUSN. "Order Flows and Probability of Informed Trading in Index Option Markets." Fall 2015.

This research project investigates the pattern of order flows (buyer-and seller-initiated trades) for S&P 500 index options, mini S&P 500 options, and the SPDR exchange-traded fund options under different market conditions. This research further examines which option among these three types of options has the highest proportion of trades initiated by those who have a better source of information. Research findings will provide useful information to options exchanges and policy makers for designing a trading mechanism to deter informed trading.

Privitello, Lucio. ARHU. "Parmenides: Philosophy and/as Law." Spring 2016.

My project will be a detailed study on the philosopher, Parmenides (515-450 BCE). This involves a new translation of 150 lines of his work entitled *On Nature*, a re-sequencing of the order of the fragments, and an extensive commentary on his work. My goal is to present a booklength study on this "father of western philosophy." Chapters of this book will also be used as journal articles and for national and international conferences on ancient Greek philosophy.

Rodriguez, Michael. SOBL. Deliberating Immigration: Policy Frames in the United States and the European Union. Spring 2016.

The sabbatical project is the first of a two-stage research agenda that analyzes how immigration) policy frames in the US and EU shape deliberations over which level of government should regulate unauthorized immigration. The sabbatical project focuses solely on the US portion of the research agenda by analyzing how four types of policy frames (historical, constitutional, functional, and political) in amicus curiae (friend of the court) briefs shape Supreme Court deliberations in immigration cases in which several states have challenged the national government's exclusive authority to regulate unauthorized immigration in the US.

Ross, Rain. ARHU. "Hello Dahling: Silent Divas of the Screen." Spring 2016.

During this sabbatical, I will research silent film stars such as Alla Nazimova, Louise Brooks, and Marlene Dietrich. Through traditional as well as movement research, the project uses the actors' narratives and the impact of the time in which they lived to feed the creation of a new choreographic work in which I will be the primary performer. This new work will then be submitted to various dance festivals for performance.

Siecienski, A.E. ARHU. "The Papacy and the Christian East: A History." Fall 2015.

This book, to be published by Oxford University Press, details the history of the papacy as it has been received or rejected by the Orthodox East. It will stand alongside the earlier book, *The Filioque: History of a Doctrinal Controversy*, as a complete history of the question from the biblical period to the present. This should allow both Catholic and Orthodox scholars to employ the book in the ongoing national and international dialogues on the papacy that began in Ravenna in 2007.

Wang, Jianrong. Library. "Cataloging Department Assessment: Where Are We Now?" Spring, 2016.

The project is to conduct a literature review of assessment in the cataloguing departments of academic libraries and determine the status and needs of such assessment, based on current library assessment trends. Assessment projects in cataloging departments are limited, and it is unclear how much existing projects align with current assessment theory and practice.

White, Wendel. ARHU. "Red Summer: Civil Conflict in the American Landscape." Spring, 2016.

During the summer of 1919 a series of race riots and lynchings throughout the U.S. came to be known as "Red Summer." The sabbatical leave will allow me to travel and take photographs depicting the sites of the riots and lynchings at twenty-five locations. The final portfolio will be prepared for exhibition and publication. This is the most recent of a series of projects that are broadly concerned with the history, memory, and material culture of the African American community.

  - Project consists of a qualitative and quantitative investigation into the perceptions of local humanitarian workers regarding disaster preparedness and capacity of disaster response in the West Bank/Gaza Strip.
- 2) Bulevich, John. SOBL. Misinformation and testing: Previous work (Chan, Thomas, & Bulevich, 2009; Bulevich, Parsow, & Thomas, under review) have examined the circumstances under which testing can lead to distortions in eyewitness memory. This project will continue research in this area to better understand the mechanisms underlying this effect.
- 3) Garcia, Luis. HLTH. A Longitudinal Evaluation of the Bachelor of Science in Health Science (BSHS): This project is an evaluation of the BSHS program. It is also my main source of scholarship, as well as the source of scholarship of 4 other faculty members. This request for course release will be used to collect data at the beginning and end of the spring semester, analyze data, and complete draft of the first article. The time will also be used to gather information on external funding and get ready to apply in the summer of 2015.

This bid waiver is for two hi-speed FastCam UX50 160K-M-8GB models that can be retrofitted to refurbish C-am fluoroscopes for obtaining hi-definition movies of moving animal skeletons for faculty and student research and teaching. It is necessary for both implementation of the XROMM imaging facility and for producing quality images and videos for teaching and research at a low cost. The XROMM facility at Stockton is being built and modeled on the Brown University facility. XROMM requires specialized equipment and retrofitting that differs from standard camera setups. Tech Imaging Services works directly with the Radiological Imaging Systems (RIS) company that will supply the refurbished fluoroscopes and retrofit these specific cameras to them. This bid waiver increase is for the Internet Backbone Extension project funded under the HETI Bonds that will provide the institution with an additional circuit to provide redundancy of the Internet connectivity for the College. The scope of work involves connecting the College through dark fiber optic cabling directly to NJEdge. NJEdge will provision the new 1GB FiberTech connection and load balance between the existing 1GB Comcast connection. The scope of work was not finalized in time to have this included in the original bid waiver request that was submitted last spring. The College has been utilizing NJEdge as its Internet provider as a shared consortium along with 53 educational institutions within the state. The NJEdge infrastructure provisions a regional optical network and statewide broadband access to connected members. NJEdge uses a number of last mile providers including Fibertech Communications and Comcast who are competitive local exchange carriers (CLECs) tariffed by the New Jersey Board of Public Utilities.
