Through June 30, 2015, total fiscal-year-to-date giving to the University was \$2,331,686. This compares to \$1,778,730 through the same period in FY 14, and \$1,981,346 in FY 13.

The **Office of Development and Alumni Affairs** is planning the Annual Stockton Golf Classic which will be held on September 29, 2015 at Stockton Seaview Hotel & Golf Club. FY15 ended as a record-breaking year for the **Richard Stockton Society** (donors who have contributed more than \$1,000 in the fiscal year). The Society included 275 members, including 94 new members at this level. The previous record for RSS members was 232 in FY13.

Unrestricted donations to the Stockton Fund (formerly known as the Annual Fund) totaled \$147,164.67 in FY15.

Direct mail and Phon-a-thon initiatives secured \$96,972 in total dollars for the 2015 giving year. This was an increase of 4% from last giving year's total dollars of \$93,947. Direct mail initiatives helped secure \$45,132. This was an increase of 44% from last giving year's direct mail total dollars of \$31,303. Also worth highlighting, was the 120% increase in unrestricted dollars raised from direct mail resulting in \$23,089 raised compared to \$10,506 raised last giving year.

- WHEREAS,** the mission of the New Jersey Department of Children and Families (NJDCF) is focused on strengthening families and achieving safety, well-being, and permanency for all New Jersey's children. NJDCF strives to incorporate the best thinking of New Jersey stakeholders, frontline workers, and supervisors to achieve positive results and improvements to the state's child welfare system; and
- WHEREAS,** since 2005, Stockton University has provided administrative and oversight services for a consortium of seven New Jersey baccalaureate programs and now master's in social work programs focusing on educating and developing a trained workforce in child welfare; and
- WHEREAS,** the University submitted a proposal on behalf of the consortium to renew and expand the contract with NJDCF; and

ABSTRACT

Through a project team that includes faculty/staff from the School of Education, including its Southern Regional Institute and Educational Technology Training Center (SRI&ETTC), Stockton University will lead a cohort of teachers and administrators from Somers Point Public Schools, a high-needs Lead Education Agency (LEA), and Mainland Regional High School, which educates the children of Somers Point in grades 9-12. The project will last three years and will examine district mentoring programs and other policies and practices that support beginning teachers. A series of high-quality professional learning opportunities as well as continuous interaction with instructional coaches from the University will support participants as they build their capacity to serve as effective mentor teachers for pre-service teachers, novice teachers, and for district peers needing assistance in instructional strategies and classroom practices.

The Mentoring Network Team composed of teacher leaders, district administrators, and University faculty and staff will create a developmental continuum of support for the novice teacher that begins during pre-service teaching and continues during a teacher's first years. The team will examine and refine district practices, including selecting and training mentor teachers, enhancing the student teaching experience, and supporting the novice teacher.

Additionally, a cohort of 20 teachers from the partner districts will participate in a comprehensive program of professional learning, which will prepare them to lead their districts' mentoring programs. Through face-to-face workshops, one-on-one coaching, and completion of online modules created for this initiative, participants will develop the capacity to identify and analyze instructional practices that successfully engage students in high-quality, cognitively-demanding lessons. As defined in the grant application, participants will introduce this "ambitious instruction cycle" to the novice teacher through an innovative model of teacher leadership (educative mentoring), which focuses on the professional growth of novice teachers by prioritizing self-reflection and continued growth.

Providing opportunities for novice teachers to successfully navigate the complex learning environment of K-12 schools requires high quality induction programs that bridge professional learning from pre-service practice through the first years in a classroom setting. Each step along the developmental continuum must be led by teacher leaders who have the capacity to observe, discuss, and guide the novice teacher through reflective practices that will improve beginning teacher practices.

If a student's cumulative GPA is below 2.0 in two consecutive (or three cumulative) semesters, the student is subject to Academic Dismissal.

When a student's term GPA is below 2.00, but the cumulative GPA is at least a 2.00, the student will be notified of "Academic Warning."

Students who subsequently earn term GPAs of at least 2.0 will be continued on probation for a maximum of 24 credits after the initial term of probation in order to raise the cumulative GPA to at least 2.0.

I. POLICY

A. Statement of Intent

Stockton University is committed to providing every student with an environment free from discrimination, harassment, intimidation and/or bullying. Prohibited discrimination, harassment, intimidation and/or bullying undermines the integrity of the student relationship, compromises equal opportunity, debilitates morale and interferes with educational productivity.

Nothing in this policy, however, shall restrict the University's ability to promptly act to ensure the safety and integrity of the University community.

B. Protected Categories

Under this policy, discrimination/harassment, intimidation and/or bullying based upon the following protected categories are prohibited and will not be tolerated: race, creed, color, national origin, nationality, ancestry, age, sex/gender (including pregnancy), marital status, civil union status, domestic partnership status, familial status, religion, affectional or sexual orientation, gender identity or expression, atypical hereditary cellular or blood trait, genetic information, liability for service in the Armed Forces of the United States, or disability, including perceived disability, physical, mental and/or intellectual disabilities.

Sexual harassment is defined as unwelcome sexual advances, requests for sexual favors, and other verbal or physical conduct of a sexual nature when, for example:

- Submission to such conduct is made either explicitly or implicitly a term or condition of an individual's employment or academic standing;
- Submission to or rejection of such conduct by an individual is used as the basis for employment and/or academic decisions affecting such individual; or
- Such conduct has the purpose or effect of unreasonably interfering with an individual's academic/work performance or creating an intimidating, hostile or offensive academic/work environment.

Examples of conduct that may, when severe, pervasive or persistent, constitute sexual harassment and are therefore a violation of this policy include, but are not limited to:

- Generalized gender-based remarks and comments;
- Unwanted physical contact such as intentional touching, grabbing, pinching, brushing against another's body or impeding or blocking movement;
- Verbal, written or electronic lewd, vulgar or obscene comments, jokes or unwanted propositions including letters, notes, e-mail, text messages, invitations, gestures or inappropriate comments about a person's clothing;
- Visual contact, such as leering or staring at another's body; gesturing; displaying sexually suggestive objects, cartoons, posters, magazines or pictures of scantily-clad individuals; or displaying sexually suggestive material on a bulletin board, on a locker room wall, or on a screen saver in areas where individuals besides the poster can view these materials;
- Explicit or implicit suggestions of sex by a faculty/staff/administrator in return for a favorable educational or employment action such as hiring, compensation, promotion, retention, grades, recommendations, etc.;
- Suggesting or implying that failure to accept a request for a date or sex would result in an adverse educational/employment consequence with respect to any academic/employment practice such as evaluation or promotional opportunity; or
- Continuing to engage in certain behaviors of a sexual nature after an objection has been raised by the target of such inappropriate behavior.

Gender-based harassment means non-sexual harassment of a person because of the person's sex and/or gender, including, but not limited to, harassment based on the person's nonconformity with gender stereotypes. Gender-based harassment is considered to be sexual misconduct.

Sexual violence is a form of sexual harassment under Title IX and refers to physical sexual acts perpetrated against a person's will or where a person is incapable of giving *consent* due to the complainant's *incapacitation* through the use of drugs or alcohol. A number of different acts fall into the category of sexual violence, including rape, sexual assault, sexual battery and sexual coercion. All forms of sexual violence are considered to be sexual misconduct.

A. Title IX Coordinator

All individuals should be aware that the Chief Officer/Title IX Coordinator oversees the entire policy and is Stockton's Title IX Coordinator whose responsibilities include, but are not limited, to overseeing all Title IX complaints and identifying and addressing any patterns or systemic problems that arise during the review of such complaints.

VIII. DISSEMINATION

Stockton shall annually distribute the policy described in this section, or a summarized notice of it, to all of its students. The policy, or summarized notice of it, shall also be posted in conspicuous locations throughout the buildings and grounds of the University. Stockton shall distribute the policy to vendors/contractors with whom Stockton has a direct relationship.

- WHEREAS,** The Board of Trustees is authorized to enter into contracts to purchase or sell land and buildings which are deemed necessary or advisable for the board to carry out the mission and purpose of the university, as indicated in NJSA 18A:64-6 (k) and (q); and
- WHEREAS,** in December 2014 the Showboat Hotel and Casino property in Atlantic City, New Jersey was purchased by the university to expand its facilities and programs in the region and contribute to the economic development of the surrounding communities; and
- WHEREAS,** due to financial and legal considerations related to the development and use of the property, the Board of Trustees concluded that it is no longer financially viable to own the property, and that the university mitigate its costs from the purchase and maintenance of the property, and expeditiously sell the property; and
- WHEREAS,** on July 8, 2015 the Board of Trustees confirmed the actions of the Executive Committee to authorize the Acting President to negotiate an agreement of sale, undertake all associated due-diligence and planning as necessary to sell the former Showboat Hotel and Casino property, and to complete the sale accordingly; and
- WHEREAS,** the Interim (formerly Acting) President has negotiated and fully vetted an agreement of sale for the Showboat Hotel and Casino property, and is working with the Buyer to complete its due diligence investigation and to complete the sale pursuant to the agreement of sale; and
- WHEREAS,** as stipulated in the agreement of sale, the obligations of the university are conditioned upon approval by the university Board of Trustees of the agreement and the sale of the property to the Buyer upon the agreed upon terms; and
- WHEREAS,** the Board of Trustees discussed in closed session the form and substance of the agreement and the terms and conditions of the proposed sale of the property; and
- WHEREAS,** the Board of Trustees has determined that the sale of the property in accordance with the agreement is in the best interests of the university and that the agreement and sale should be authorized and approved, in accordance with the terms of the agreement and in accordance with university policy and other applicable laws of the State; now therefore be it,
- RESOLVED,** that the Board of Trustees hereby approves the sale of the property in accordance with the agreement of sale, authorizes the university to enter into the agreement of sale, authorizes the Interim President to execute the agreement of sale on behalf of the university and to complete all associated due-diligence and planning as necessary to complete the sale of the Showboat Hotel and Casino property to the Buyer, and hereby ratifies and confirms all acts heretofore taken in furtherance of the foregoing by the Acting and Interim President and other officers of the university.
